North Anna, Unit 2, Reactor Vessel Head (RVH) Replacement

During the week of January 6-10, 2003, the Office of Nuclear Reactor Regulation (NRR) and Region II staff will be visiting North Anna Power Station to inspect the licensee's progress on replacing the RVH for Unit 2. This will include an examination of how the licensee was able to reconcile the differences between the replacement RVH and the formerly installed head under the American Society of Mechanical Engineers (ASME) Code Section XI. As part of this inspection effort, the staff plans on reviewing the licensee's modification package, reconciliation report, new design specifications, and ASME data package. Work is proceeding to close the containment hole that was made to support the transfer of the heads.

Contract Awards

On December 31, 2002, a delivery order was awarded to Foxx and Co. for Financial Management Services in accordance with the U.S. General Services Administration Schedule procedures. This performance-based order provides for financial statement preparation, account reconciliation and financial management advice and guidance. The order contains a 3-month base period, a 9-month option, and four one-year option periods. The estimated ceiling amount of the order, including options, is \$4,543,271.

Contract No. NRC-33-03-321, entitled "NRC Issuances and Indexes", was awarded to Kelly & DeWitt, Inc., on December 20, 2002, to allow for the preparation of manuals in hardbound and electronic format. The period of performance for this effort is December 20, 2002 through December 19, 2007. The total estimated cost for this effort is \$355,334.40. The following streamlining initiatives were used in awarding this contract: (1) combined synopsis/solicitation; (2) reduced proposal preparation time; (3) set deadline for proposer's questions; (4) limited number of pages in proposal; and (5) electronic coordination of the final evaluation report.

Contract No. NRC-02-03-004, entitled "Technical Assistance for Reviewing Licensee Submittals Concerning Decommissioning", was awarded to Southwest Research Institute (SwRI) on January 1, 2003. This Cost Plus Fixed Fee task order is a "work for others" award to SwRI to maintain essential capabilities at the Center for Nuclear Waste Regulatory Analyses (CNWRA). The total estimated cost of this effort is \$624,215. The period of performance is January 1, 2003 through December 31, 2004. The following streamlining initiatives were used in awarding this contract: (1) class justification for other than full and open competition; (2) statement of work electronically transmitted; (3) waiver of audit requirements; and (4) simplified evaluation report.

Pen Virginia Operating Company - General License Gauge User

On December 31, 2002, the Regional Office issued a Confirmatory Action Letter to Pen Virginia Operating Company. The purpose of the Letter was to confirm actions the mining company has put in place to control access to a fixed nuclear gauge, found by NRC inspectors to be abandoned at the Company's Fork Creek Mine near Alum Creek, West Virginia.
