Briefing of Representative Nita Lowey Staff

On February 19, 2003, Nuclear Reactor Regulation staff met with Ari Selman of Representative Nita Lowey's staff to discuss Indian Point nuclear security and emergency preparedness issues. Nuclear Security and Incident Response and Region I staff joined via teleconference.

Issues discussed included various security and emergency preparedness issues such as the resumption of force-on-force exercises, physical fitness and training requirements for security guards, and evacuation time estimates.

<u>License Application Received from U.S. Enrichment Corporation</u>

On February 12, 2002, NRC received a license application, from the U.S. Enrichment Corporation (USEC), to construct, and operate for 5 years, a gas centrifuge uranium enrichment test and demonstration facility (Lead Cascade). The proposed facility will be based on Department of Energy (DOE) advanced gas centrifuge technology. USEC plans to assemble and operate the Lead Cascade in an existing DOE gas centrifuge building located at the Portsmouth Gaseous Diffusion Plant site in Piketon, Ohio. The Lead Cascade, which will consist of up to 240 centrifuges, will provide USEC with reliability information on the machines and auxiliary systems, as they would be used in commercial operations. USEC is expected to submit a license application for its commercial-scale facility in late 2004 or early 2005.

Staff Meets with Kiski Valley Water Pollution Control Authority

On February 12, 2003, NRC held a meeting, open to the public, with the Kiski Valley Water Pollution Control Authority (KVWPCA), BWXT, and the Pennsylvania Department of Environmental Protection (PADEP), to discuss remediation of the contaminated lagoon at the KVWPCA site. A reporter from the Valley News Dispatch also participated by telephone. Much of the discussion focused on options for meeting the unrestricted release criteria under the License Termination Rule, including the option of demonstrating that the contaminated lagoon already meets the criteria, in its present configuration. NRC staff focused on what KVWPCA needs to do to meet NRC criteria. KVWPCA and PADEP would have to discuss any non-radiological considerations. NRC staff emphasized the importance of KVWPCA submitting a decommissioning plan (DP) and explained how submittal of the DP would be noticed and how the DP would be reviewed. In response, KVWPCA committed to submit a schedule, by March 12, 2003, for the development of its DP.

Prospective Sale of Foster Wheeler Environmental Corporation to Tetra Tech, Inc.

On February 18, 2003, Tetra Tech, Inc., issued a press release announcing its intent to purchase Foster Wheeler Environmental Corporation (FWENC) from its parent company, Foster Wheeler, Ltd. According to the press release, the companies have reached a definitive agreement on the purchase, with the transaction expected to close by the end of March 2003.

NRC is currently reviewing an application submitted by FWENC for a 10 CFR Part 72 license for the proposed Idaho Spent Fuel facility. The application was submitted in November 2001, under a contract with the Department of Energy. The staff will assess the impact of the proposed sale of FWENC on the pending application. At a minimum, revised financial assurance information will need to be submitted after the sale.

Inspection of Spent Fuel Dry Storage and Transportation Cask Fabrication Activities in Japan

From January 27 to February 7, 2003, an inspection team from the Spent Fuel Project Office (SFPO) performed an inspection of selected fabrication activities for spent fuel dry storage and

transportation casks being manufactured in Japan for use in the U.S. The team examined the activities at two fabrication sites, Hitachi Zosen Diesel and Engineering Company, Ltd., in Ariake, and Kobe Steel, Ltd., in Takasago. The team found the construction quality to be excellent and the licensee and certificate holder oversight adequate. The team identified some areas requiring corrective action and will recommend appropriate action to SFPO management. The team plans to issue two formal inspection reports, one to each certificate of compliance holder in late March 2003.

List of Approved Spent Fuel Storage Casks: Fuel Solutions Revision (Part 72)

A direct final rule that revises the Fuel Solutions cask system listing in the list of approved spent fuel storage casks was published in the Federal Register on February 21, 2003 (68 FR 8445). This action modifies the technical specifications for the cask system to permit the return of the W-21 canister to the storage cask if it must be removed from the storage cask. The direct final rule becomes effective May 7, 2003.

Contract Award

Contract No. NRC-07-03-399 was awarded on a competitive basis to ICF Consulting, Inc. on February 20, 2003. The objective of this contract is to obtain technical support for the integration of access authorization and fitness-for-duty rulemaking efforts. The contract has a three-year period of performance (February 20, 2003 through February 20, 2006) with two one-year options. The total contract value, to include options, is \$2,065,664. The streamlining initiative utilized was NRC's synopsis waiver for technical assistance requirements.

Other inquiries were about the Clinton/Markey proposal for tracking radioactive materials, plant security, missing moisture density gauges, dirty bombs and emergency preparedness.

Region I Public Affairs supported the Regional Administrator at Representative Engel's meeting in New York with local officials about emergency preparedness in the counties surrounding Indian Point.

Japanese NHK TV interviewed the Director of the Office of Nuclear Reactor Regulation and filmed the Technical Library and Technical Training Center for a program to air next month in Japan.

NRC Meeting with Elected Officials Regarding Indian Point

At the request of New York Congressman Eliot Engel, on February 21, 2003, the Region I Regional Administrator met with Congressman Engel and numerous elected officials from the area around the Indian Point site. The meeting was held at Mercy College in Westchester County, New York. In addition to Congressman Engel, participants included Congresswoman Nita Lowey, State Assemblyman Richard Brodsky, State Assemblywoman Sandra Galef, and more than 20 other local elected officials and staff. Local elected officials expressed their dissatisfaction with emergency planning for the Indian Point site, and advocated a more effective response to their concerns from the federal government.

Quarterly Presentation Before Community Decommissioning Advisory Committee

On February 19, 2003, Region I staff attended the Community Decommissioning Advisory Committee (CDAC) meeting regarding the Connecticut Yankee (CY) facility in Haddam Neck, Connecticut. The Region I staff provided a summary of NRC inspection findings from the last quarter, and an overview of current inspection plans. Approximately twenty-five people attended the meeting, including members of CDAC, the licensee and the public.
