Nuclear Procurement Issues Committee (NUPIC) Vendor Meeting

On June 8-10, 2004, Office of Nuclear Reactor Regulation (NRR) staff attended the 13th Annual NUPIC Vendor meeting held in Indianapolis, Indiana. The staff conducted a presentation on several topics including, NRC participation on NUPIC audits, future NUPIC/NRC interaction, NRC participation on American Society of Mechanical Engineers (ASME) nuclear quality assurance (NQA) committees, and staff efforts to assess options for adopting other international quality assurance standards, as described in SECY 03-0117, "Approaches for Adopting More Widely Accepted International Quality Standards." Approximately 140 vendor and 50 utility representatives, including several international utilities, attended the meeting.

NRC Regulatory Issue Summary (RIS) 2004-09: Status on Deferral of Active Regulation of Ground-Water Protection at *In Situ* Leach Uranium Extraction Facilities

NRC issued the subject RIS dated June 7, 2004, which supersedes RIS 2004-02 in its entirety, to inform interested parties of: (1) NRC's plans for the deferral of active regulation of ground-water protection at *in situ* leach uranium extraction facilities; and (2) the comments received in response to RIS 2004-02. No specific action nor written response is required to this RIS. A notice of availability will be published in the Federal Register. In a related action, the staff has scheduled meetings with the State of Nebraska for the week of June 28, 2004, to begin comparison of the State's ground-water protection program to the NRC's program. Similar meetings with the State of Wyoming are tentatively planned for late this summer.

5<sup>th</sup> Annual Meeting of the Forum on Stakeholder Confidence

Division of High-Level Waste Repository Safety (HLWRS) staff attended the fifth annual meeting of the Forum on Stakeholder Confidence (FSC), sponsored by the Radioactive Waste Management Committee of the Nuclear Energy Agency. The meeting took place during June 1-3, 2004, in Paris, France. Of particular note at this meeting were three topical sessions: (1) "Decision Making Processes at the Strategic Choice Stage - How Different Stakeholders Are Involved, and Which Values Are Taken into Account"; (2) "Media Relations"; and (3) "Addressing Issues Raised by Stakeholders - Impacts on Process, Content, and Behavior in Waste Organizations." As part of the third topical session, the staff presented a paper entitled, "Building Confidence in Nuclear Waste Regulation - How NRC is Adapting in Response to Stakeholder Concerns."

Annual Meeting of the Northeast High-Level Radioactive Waste Task Force of the Council of State Governments

On June 2-3, 2004, Spent Fuel Project Office (SFPO) staff presented a status of SFPO activities to the annual meeting of the Northeast High-Level Radioactive Waste Task Force of the Council of State Governments. The presentation covered the (1) SFPO licensing of storage facilities; (2) the recent rulemaking on 10 CFR Part 71, "Packaging And Transportation of Radioactive Material"; (3) the Package Performance Study (PPS); (4) the two active National Academy of Sciences studies on spent fuel storage and high-level waste transportation; and (5) Private Fuel Storage. Several offices in the Department of Energy and Department of Transportation's Federal Railroad Administration also made presentations. The State Government representatives expressed appreciation for the NRC presentation and had many questions on the PPS and the availability of future NRC work on security (such as the storage and transportation Vulnerability Studies).

Research Monthly Seminar

On June 10, 2004, RES staff presented a seminar on the AP1000 design and its safety features to NRC staff as a part of monthly seminars on critical research projects and other topics of interest in RES. This seminar provided an overview of the AP1000 design and its safety features, with particular emphasis on thermal-hydraulic and severe accident analysis issues addressed during the Design Certification effort, and how experimental and analytical work performed by the RES helped to resolve those issues.

Town Hall Meeting in San Luis Obispo, CA

On June 9, 2004, Region IV and NRR staff conducted a town hall meeting in San Luis Obispo, California to discuss issues regarding the Diablo Canyon Nuclear Power Plant. The staff presented the results of NRC inspections following the December 22, 2003, San Simeon earthquake, which was the subject of a previous public meeting conducted by the staff on February 4, 2004. The staff addressed specific questions on the structural design of the facility to withstand the largest postulated earthquake and the seismic faulting in the vicinity of the plant. The staff also addressed questions regarding plant security, the proposed onsite independent spent fuel storage installation, and other topics related to the safety performance of the plant. Over 100 people, including members of the public and representatives from interest groups attended the meeting.

River Bend - Emergency Exercise

On June 9, 2004, Region IV, led by the Regional Administrator, participated in the biennial graded emergency exercise for the River Bend Station. The State of Louisiana and local authorities also participated in the exercise.
