SUBJECT: CONGRESSIONAL DISTRICT OUTREACH

This is to inform you about an effort to address U.S. Nuclear Regulatory Commission (NRC) outreach to local Congressional District offices. This effort has been initiated to address the Chairman's interest, which was expressed during the October 14-15, 2004, Senior Management Meeting.

A working group, Co-Chaired by Rosetta Virgilio, Office of State and Tribal Programs (STP) and Betsy Keeling, Office of Congressional Affairs (OCA), has been established, with participating members from the Office of Public Affairs (OPA), Region III, and the Office of the Executive Director for Operations (OEDO). The working group charter (Attachment 1) outlines a process and criteria for timely outreach with selected Congressional District offices (Attachment 2) to inform them about NRC regulatory activities of interest and to establish points of contact for exchange of information.

The working group, in coordination with Regional management and the Regional State Liaison Officer (RSLO), will initiate roll out of the program through calls to Congressional District staff from two to three of the Congressional representatives who responded positively to OCA's initial calls to Washington, D.C. Congressional Offices informing them about this effort. The calls will offer face-to-face meetings between Regional management, the RSLO, and Congressional District staff. Results of these calls and meetings will provide input into future outreach activities. The working group will also strive to establish closer connectivity among NRC Headquarters Program Offices, STP, OCA, OPA, OEDO, the Director of Communications, and the Regions, to include Public Affairs Officers and RSLOs, to better anticipate, communicate, and disseminate information of interest to Congressional District offices. The working group will provide a final status report of these activities to a Steering Committee, comprised of senior managers from the above organizations, with recommendations and alternatives for future expansion of this effort and the associated resource implications. The time frame for completion of this effort is the second quarter of 2005.

**COMMUNICATIONS WORKING GROUP ON  
OUTREACH TO CONGRESSIONAL DISTRICT OFFICES  
CHARTER - PHASE I**

**Objectives:**

1. Engage in timely outreach with Congressional District offices to inform them about U.S. Nuclear Regulatory Commission (NRC) regulatory activities of interest, and to establish points of contact for exchange of information.
2. Evaluate lessons learned, i.e., successes, necessary improvements, and FTE requirements, by seeking feedback from Congressional District offices, and make recommendations to the respective NRC and Regional Offices and Director of Communications (DOC), whether additional resources are necessary to continue and expand Congressional District outreach.
3. Establish closer connectivity among the NRC Headquarters Program Offices, the Office of State and Tribal Programs (STP), Office of Congressional Affairs (OCA), Office of Public Affairs (OPA), DOC, and the Regions, to include Public Affairs Officers (PAOs) and Regional State Liaison Officers (RSLOs), to better anticipate, communicate and disseminate information of interest to Congressional District offices.

**Scope of Work:**

Develop a process and criteria for timely outreach with selected Congressional District offices in two phases.

1. The OCA will develop a list of Congressional representatives, to include up to three from each NRC Region, if possible, who have expressed a general or specific interest in NRC regulated activities. The OCA listing will define the issues of interest. The OCA will contact the selected DC-based Congressional offices for each NRC Region and discuss their interest in having NRC share information with their Congressional District staff. For those positive DC-based Congressional responses, OCA will work together with STP and OPA to inform the Regional Administrator, RSLO and PAO of Congressional interest so that OCA and the Region may proceed to arrange the initial contact with the Congressional District staff to: (1) offer an opportunity to meet and discuss NRC's regulatory responsibilities and activities of interest; (2) establish points of contact for subsequent inquiries; (3) provide information about NRC Web-based information; and (4) offer to routinely share information, such as enforcement notifications, preliminary notifications, and press releases, that may be of interest to them. Outreach to the Congressional District staff would be triggered by situations (e.g., events, issues) where the RSLO, OCA, and OPA would normally, pro-actively engage either the Governor designees, DC-based Congressional offices, or the media. Implementation time frame: **First Quarter FY 2005.**

2. Define a process for closer in-house communications between the NRC Headquarters Program Offices STP, OCA, OPA and the Regions. This will include consideration of: (1) engaging in periodic teleconferences to keep respective Office staff abreast of evolving issues; (2) coordinating notifications about NRC regulatory activities to Governor designees, DC-based and Congressional District offices, and the media; and (3) identifying opportunities for the Commission and senior NRC management to meet, while on official travel, with State and Congressional District office representatives and the media to discuss NRC regulatory activities of interest to them.

#### **Future Work:**

Based upon an evaluation of the Phase I Congressional meetings response and feedback, the OCA will recommend implementation of Phase II broader contact with a greater number of DC-based Congressional offices to determine their desire for NRC to routinely share information with their Congressional District staff. Implementation time frame: TBD, dependent upon Phase I interactions

#### **Work Products:**

The Working Group will report to and provide draft final work products and briefings, as necessary, to a Steering Committee comprised of OCA, STP, OPA, DOC, and the Deputy Executive Director for Reactor Programs. The work products to be completed under Phase I of this project include: (1) a final Working Group Charter; (2) a framework and milestone schedule for identifying and contacting Washington, DC-based and local Congressional District offices to exchange timely information on nuclear-related issues; (3) key messages and draft agenda for meeting with Congressional District offices; (4) status briefing for Deputy Executive Directors for Operations, Regional Administrators, DOC, Chief Financial Officer, the General Counsel, and Commissioners' executive assistants to include recommendations, based on feedback from the Congressional District staff and the respective NRC and Regional Offices, on whether to continue and expand Congressional District office outreach; (5) identifying mechanisms for enhancing in-house communications between the NRC Headquarters Program Offices, STP, OCA, OPA and the Regions; and (6) a final status report of the Phase I activities with recommendations and alternatives for future expansion of this effort and the associated resource implications.
