## Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending July 27, 2005

### NRC Information Notice (IN) 2005-21: Plant Trip and Loss of Preferred AC Power From Inadequate Switchyard Maintenance

On July 21, 2005, NRR issued the subject IN to power reactor licensees to inform them about loss of power events as a result of inadequate preventive and corrective maintenance practices on switchyard circuit breakers and current transformers. No specific action or written response is required for INs, however, it is expected that recipients will review the information for applicability to their facilities and consider actions, as appropriate, to avoid similar problems.

#### Meeting with the ASTM D-33 Coatings Committee

On July 25 - 26, 2005, the staff met with representatives of the American Society for Testing and Materials (ASTM) D-33 Committee, which is responsible for the standard on Protective Coatings for Power Generation Facilities. The purpose of the meeting was to discuss how improvements in the ASTM standard could support resolution of Generic Safety Issue (GSI)-191, "Assessment of Debris Accumulation on PWR Sump Performance," by specifying maintenance practices. As a result of this meeting, the ASTM D-33 committee will survey the industry experience related to containment coating failures to justify the need for and scope of inspection standards.

#### Pre-Licensing Meeting Regarding New Transport Package for Medical Isotopes

On July 21, 2005, Spent Fuel Project Office staff met with BNG Fuel Solutions and Tyco Healthcare/Mallinckrodt Medical regarding the proposed Model MIDUS transportation package. The package is being developed for domestic and international transport of medical isotopes. The discussion centered around the conceptual design and the analyses and testing that will be performed. BNG plans to submit an application for package approval in February 2006.

North American Electric Reliability Council (NERC), Federal Energy Regulatory Commission (FERC), NRC, and Academic Community Meet to Discuss Electric Grid Analysis

On July 18 -19, 2005, the subject meeting sponsored by NERC was held in Oak Ridge Tennessee. Discussions focused on the application of complex system theory to analyses of the electric grid. The information gathered from the meeting will be used to update the RES grid study.

# Office of Nuclear Security and Incident Response (NSIR) Items of Interest Week Ending July 27, 2005

#### Public Meeting with the Nuclear Energy Institute (NEI)

On July 25, 2005, Division of Preparedness and Response/Emergency Preparedness Directorate staff held a public meeting with NEI, to discuss issues related to submission of an emergency plan for a new reactor at the early site permit (ESP) application stage. A key discussion topic was that such a submission could utilize designated placeholders (e.g., inspections, tests, analyses, and acceptance criteria [ITAAC], or ESP permit conditions) to cover various aspects of emergency planning that are not fully addressed at the ESP stage, and allow for a predictive finding of "reasonable assurance."

#### Federal Register Notice Announcing the Emergency Preparedness Public Meeting

On July 28, 2005, a Federal Register Notice was published announcing a public meeting to discuss selected topics for the review of emergency preparedness regulations and guidance. <u>List of Approved Spent Fuel Storage Casks: NAC-UMS Revision 4 - Direct Final Rule (AH75-Part 72)</u>

On July 25, 2005, NRC published a direct final rule in the Federal Register (70 FR 42485) that adds Amendment 4 to the Certificate of Compliance (CoC) Number 1015. This amendment will modify the cask design by replacing the specific term "zircaloy" with the more generic term "zircaloy alloy," revising other definitions, adding an alternate site-specific design basis earthquake analysis, and incorporating editorial and administrative changes.

National Source Tracking of Sealed Sources (AH48 - Parts 20, 32, and 150)

On July 28, 2005, a proposed rule was published in the Federal Register (70 FR 43646) that would amend NRC regulations to implement a National Source Tracking System for certain sealed sources. The proposed amendment would require licensees to report certain transactions involving sealed sources to the National Source Tracking System.

#### Entergy Announces Plan to Provide Backup Power for Indian Point Sirens

On July 28, 2005, Entergy issued a press release announcing its plan to provide backup power for the sirens in the 10-mile emergency planning zone for Indian Point. The announcement follows recent events in which all sirens were unavailable due to an equipment failure on July 19, 2005, and twenty sirens were unavailable due to weather induced power outages on July 27, 2005. Entergy stated that the design and deployment of the backup power system is expected to take up to two years. Department of Homeland Security/Federal Emergency Management Agency (DHS/FEMA) review and approval is required for the new siren system design.
