REMARKS: IMC 1245 (Qualification Program for the Office of Nuclear Reactor Regulation Programs ) has been revised to move responsibility for maintaining the training qualification requirements contained in Appendix C6, "Emergency Preparedness Inspector" to NSIR, unassign Appendix C9 as the "Construction Inspector Technical Proficiency Training and Qualification Journal" so that it can be assigned in the new IMC for construction activities, clarify that the qualification board chairman is responsible for sending the results of the board to the program office, and to incorporate minor editorial changes.

IMC 1245 Att 1 (General Overview of the Inspector Training and Qualification Program) has been revised to reflect the new title of Appendix C-9 (Reserved) in the inspector training flowchart, and to incorporate editorial comments.

IMC 1245 Att 2 (Inspector Competencies) has been revised to incorporate editorial comments.

IMC 1245 Att 3 (General Orientation Topics) has been revised to incorporate editorial comments.
