Meeting with Representatives of the Federal Energy Regulatory Commission (FERC)

On November 8, 2006, the staff met with FERC to get familiarized with the proposed 107 North American Electrical Reliability Council (NERC) standards that apply to Nuclear Power Plants. These standards are currently under review for approval by the council.

Public Meeting with Davis-Besse

On November 7, 2006, the staff participated in a public meeting with representatives from the Davis-Besse plant. The meeting was a pre-submittal meeting to review expectations regarding the licensee's intent to submit a license amendment request to convert their Technical Specifications to Improved Standard Technical Specifications. The licensee anticipates application submittal in July 2007.

Issuance of the Renewed Operating License for the Monticello Nuclear Generating Plant

On November 8, 2006, the operating license for the Monticello Nuclear Generating Plant was extended for an additional 20 years. The expiration date for the renewed license is September 8, 2030. Nuclear Management Company, LLC, submitted the license renewal application to the NRC by letter, dated March 24, 2005. The staff completed its review in less than 20 months. The staff's evaluations are documented in its safety evaluation report, NUREG 1865, issued in October 2006, and in Supplement 26 to the Generic Environmental Impact Statement, dated September 2006.

Public Meeting About Technical Basis for Part 26, Subpart K

On November 7, 2006, the staff held a public meeting with stakeholders to present the technical basis of Subpart K, "[Fitness for Duty] (FFD) Programs for Construction" of the 10 CFR Part 26 draft final rule. Subpart K was not included in the proposed rule package that was issued for public comment. Representatives from the Nuclear Energy Institute, Union of Concerned Scientists, International Brotherhood of Electrical Workers, and others attended the meeting. The staff emphasized that Subpart K requirements are to assure that construction workers are not impaired while constructing plant systems, structures, and components, and that Subpart K requirements are less burdensome in comparison to the former FFD requirements.

Public Meeting With Nuclear Energy Institute on 10 CFR Part 72 License and Certificate of Compliance Terms

On November 7, 2006, staff met with the Nuclear Energy Institute (NEI) to understand the industry views on the issues for initial and renewal terms for 10 CFR Part 72 licenses and Certificates of Compliance (CoCs). NEI presented the industry views on numerous aspects of Part 72 License and Certificate of Compliance Terms, including: (1) longer terms for the Part 72 Certificate of Compliance; (2) "re-approval" versus "renewal" in Part 72; (3) the 20-year terms; (4) record keeping requirements for loaded casks at each site; and (5) new license conditions during renewal.

National Source Tracking of Sealed Sources (AH48 - Parts 20, 32, and 150)

On November 8, 2006, a final rule was published in the Federal Register (71 FR 65686) that amends NRC regulations to implement a National Source Tracking System for certain sealed sources. The amendment requires licensees to report certain transactions involving those sealed sources to the National Source Tracking System and to provide an initial inventory of nationally tracked sources to the system. The amendment also requires manufacturers to assign a unique serial number to each nationally tracked source. The final rule becomes effective February 6, 2007.
