Vendor Inspection of Veridiam Incorporated

During June 4-7, 2007, staff conducted an inspection at the Veridiam Incorporated (Veridiam) facility in El Cajon, California. Veridiam supplies safety-related nuclear fuel channel tubing to AREVA ANP. The inspection team reviewed the implementation of the 10 CFR Part 21 program, selected portions of the Part 50 Appendix B Quality Assurance program, and assessed Veridiam's in-process manufacturing controls. No findings or non-conformances were identified.

Reactor Oversight Process Public Meeting

On June 13, 2007, the staff held the monthly Reactor Oversight Process (ROP) Public Meeting. The purpose of this meeting was to allow discussion on staff initiatives and provide a forum for industry feedback. Meeting attendees discussed mitigating systems performance index implementation, safety culture integration into the reactor oversight process, performance indicator issues, and open and new frequently asked questions for the ROP.

Quality Assurance Audit of Center for Nuclear Waste Regulatory Analyses

From June 5-8, 2007, NRC staff observed an internal quality assurance audit of the Center for Nuclear Waste Regulatory Analyses (CNWRA), in San Antonio, Texas. The purpose of the audit was to verify that the CNWRA Quality Assurance Program is being effectively implemented. All quality assurance programs were audited. Staff concluded that the CNWRA is effectively implementing its Quality Assurance Program.

Louisiana Energy Services Management Meeting

On June 11, 2007, staff from the NMSS, the Office of Nuclear Security and Incident Response, the Office of the General Counsel, and Region II held a semiannual management meeting with Louisiana Energy Services (LES) staff, to discuss management issues related to the LES uranium enrichment project in Lea County, New Mexico. Discussions included: the status of current licensing and legal actions, security issues, construction plans, design changes, and schedules.

Joint Canada - U.S. Guide for Radioactive Material Transportation Package Design

In a letter dated June 7, 2007, the U.S. Department of Transportation (DOT) issued the draft "Joint Canada - United States Guide for Approval of Type B(U) and Fissile Material Transportation Packages." The guide was developed by a DOT, NRC, and Canadian Nuclear Safety Commission combined staff Working Group. The guide has been developed to facilitate U.S./Canadian validation of each other's Competent Authority approvals.

Meeting with Energy Solutions on New Package Design

On June 13, 2007, NRC staff met with staff from Energy Solutions, to discuss the design and analyses of the impact limiters, for its proposed new transportation package for irradiated reactor hardware. The purpose of the meeting was to discuss the use of Energy Solution's in-house computer code, instead of physical drop tests, to demonstrate the performance of the impact limiters. NRC staff identified the limitations of the computer code, and stated that a more detailed model of the impact limiters, as part of the cask system, with the appropriate benchmarks, will be needed to replace the physical tests.

Briefing on the National Academy of Sciences (NAS) Report, "Assessment of the Performance of Engineered Waste Containment Barriers"

On June 4, 2007, the staff attended a technical briefing regarding a NAS report that describes the development of guidelines for the direct monitoring of engineered system performance and for implementing performance-based designs. The report identifies specific methods for monitoring engineered barrier performance and models for estimating infiltration through covers. The results of this study are particularly relevant for NRC-licensed facilities such as disposal and decommissioned sites that incorporate engineered barriers to preclude the release of radioactive materials, and could influence designs used to implement the provisions of 10 CFR 20.1406, "Minimization of Contamination."

Proposed Rule on Requests by Potential Parties for Access to Sensitive Unclassified Non-Safeguards Information and Safeguards Information Published (AI08 - Part 2)

On June 11, 2007, the NRC published a proposed rule in the *Federal Register* (72 FR 32018) that would amend the regulations to provide for expedited Commission review of orders on requests by potential parties for access to certain sensitive unclassified non-safeguards information and Safeguards Information. The comment period for this action closes July 11, 2007.

Draft Statement of Policy on Conduct of New Reactor Licensing Proceedings

On June 11, 2007, the NRC published a document in the *Federal Register* (72 FR 32139) requesting public comment on a statement of policy under consideration by the Commission. The draft statement of policy concerns the conduct of new reactor licensing adjudicatory proceedings. The Commission is considering this action in view of the anticipated receipt of a number of applications for combined licenses for nuclear power reactors expected to be filed within the next two years. The comment period on this action closes August 10, 2007.
