Dear Ms. Girard:

This is in reference to your letter dated July 10, 2006 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 29-17001-02. We have also received the Parent Company Guarantee dated March 31, 2007. The below requested information was contained within our letter dated August 4, 2006. In order to continue our review, we need the following additional information:

1. Because the required amount of financial assurance has changed, a new Certification of Financial Assurance needs to be submitted. Please closely follow the model on page A-23 of NUREG-1757 Volume 3, "Consolidated NMSS Decommissioning Guidance, Financial Assurance, Recordkeeping, and Timeliness."
2. A Chief Executive Officer's letter has not been received to support the Parent Company Guarantee as stated in NUREG-1757 Volume 3. The Chief Executive Officer (CEO) letter (Section A.13.4) is a letter from the CEO of the licensee that (1) certifies that the licensee is a going concern, (2) identifies the amount of the licensee's tangible net worth, (3) specifies whether the licensee is required to file a Form 10-K with the U.S. Securities and Exchange Commission, and (4) states the date on which the licensee's fiscal year ends. Please submit a Chief Executive Officer's letter. Please follow closely the model shown on page A-115 of NUREG-1757, Volume 3.
