As discussed during our conversation with the NRC project manager yesterday, we enclose herewith a copy of proposed Revision 11 HI-STAR 100 TSAR Figure 2.1.1 entitled "Holtec Damaged Fuel Container for Dresden Unit-1/Humboldt Bay SNF." This figure has been revised to add a small amount of detail, making it exactly the same as transportation SAR Figure 1.2.10, Revision 9. The additional detail on the figure is necessary to allow the removal of Holtec Design Drawings 1783 and 1784 from TSAR Section 1.5. As we agreed, TSAR Figure 2.1.1 now contains the appropriate amount of detail for control under the 10 CFR 72.48 process.
