By letter dated June 30, 2007, Packaging Technology, Inc. (PacTec) submitted an application in accordance with 10 CFR Part 71 for a Certificate of Compliance (CoC) under Docket No. 71-9305 for the TRUPACT-III shipping package.

This letter acknowledges receipt of your application and informs you that the application appears to contain the necessary information to begin our technical review. We have established a schedule for the technical review of this application. The schedule allows for the staff to issue a possible request for additional information (RAI) by February 2008. If no RAI is needed, and based on the staff's evaluation, the CoC may be issued approximately at that time. To meet the schedule, it is incumbent upon PacTec to respond promptly (i.e., within two and a half months) and comprehensively to any RAI. The CoC is scheduled to be issued by July 2008 if there is only one round of RAI as a result of the technical review.

In general, no additional changes to the application will be allowed except for those minor changes that result in responding to an RAI. Additional changes, supplements, or enhancements may be treated as a new application.
