Thank you for your letter of July 30, 2007, in response to our letter and Notice of Violation (Notice) dated July 10, 2007. Our preliminary review of your July 30, 2007, letter found that it was lacking sufficient information regarding the corrective actions taken in response to the identified findings. Accordingly, on August 15, 2007, you were telephonically contacted by Janine F. Katanic, Ph.D., of my staff, and were requested to provide additional clarifying information regarding your corrective actions. On August 22, 2007, you submitted, via electronic mail, a clarification of your original response that included a more thorough description of your corrective actions. We have reviewed your reply and subsequent clarification and find them responsive to the concerns raised in the Notice. We will review the implementation of your corrective actions during future inspections to determine that full compliance has been achieved and will be maintained.
