Dear Dr. Lambo:

On August 20, 2007, Steven Courtemanche of this office conducted a safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selected examination of representative records. Additional information provided in the telephone conversation on February 26, 2007 between Steven Perch, M.D. and this office was also examined as part of the inspection. The findings of the inspection were discussed with Shih-min Lo, Ph.D. of your organization at the conclusion of the inspection.

Within the scope of this inspection, no violations were identified. It is our understanding from our discussion with Dr. Lo, that you will be submitting a license amendment requesting that Dr. Perch be removed from the license as an authorized user since he is no longer associated with your practice. If your understanding differs from the above, please inform us in writing.
