Per communication with Mary Freeman, the record of E. okatie reported from the Savannah River floodplain could not be confirmed. The only material saved from that collection turned out to be E. zonatum. Despite this, I would have recommended that you do the survey anyways, since you are definitely within the potential range of this species. Thanks for doing the survey. Please send me your survey data when you get a chance.
