
Over the past week I have had the opportunity to visit with a number of my constituents in northern Colorado about the proposed uranium mining site in Weld and Larimer counties. I am convinced that the comment period for the Commission's Generic Environmental Impact Statement for uranium milling facilities must be extended.

The potential impacts to the rural communities of northern Colorado are simply too significant to not allow area residents ample time to study the ramifications of this project on their health, property, and livelihood. We owe the people of northern Colorado a thorough, open, and fair process through which they can make informed decisions and comment effectively on the merits of this project.

Earlier this month I expressed to the commission my strong opposition to any effort that would degrade water quality standards for uranium milling facilities. I reiterate my uncompromising conviction that the integrity of our water supply is of paramount importance. We must ensure a safe and dependable supply of water to northern Colorado homes, ranches, and farms.

Again, I urge the NRC to extend the comment period for the GEIS on uranium milling facilities. The people of Colorado deserve nothing less.
