Note the following information:

Random Vehicle Inspections

If you are stopped at the guard gate for a random inspection, you must:

- Step out of your car wearing your badge
- Open all doors, the trunk and compartments inside your vehicle
- Stand to the side until the security guard has completed his search and given the go ahead. Close the trunk, compartments and doors, then proceed to your destination

Items prohibited on SRS

The following items are PROHIBITED on SRS:

- Weapons, firearms and simulated firearms (example, real looking toys)
- Ammunition or incendiary devices, explosive materials such as firecrackers
- Alcoholic beverages (or empty cans or bottles of alcoholic beverages)
- Chemical irritants such as mace or pepper spray (small containers no greater than two ounces can be in your possession)
- Stun guns

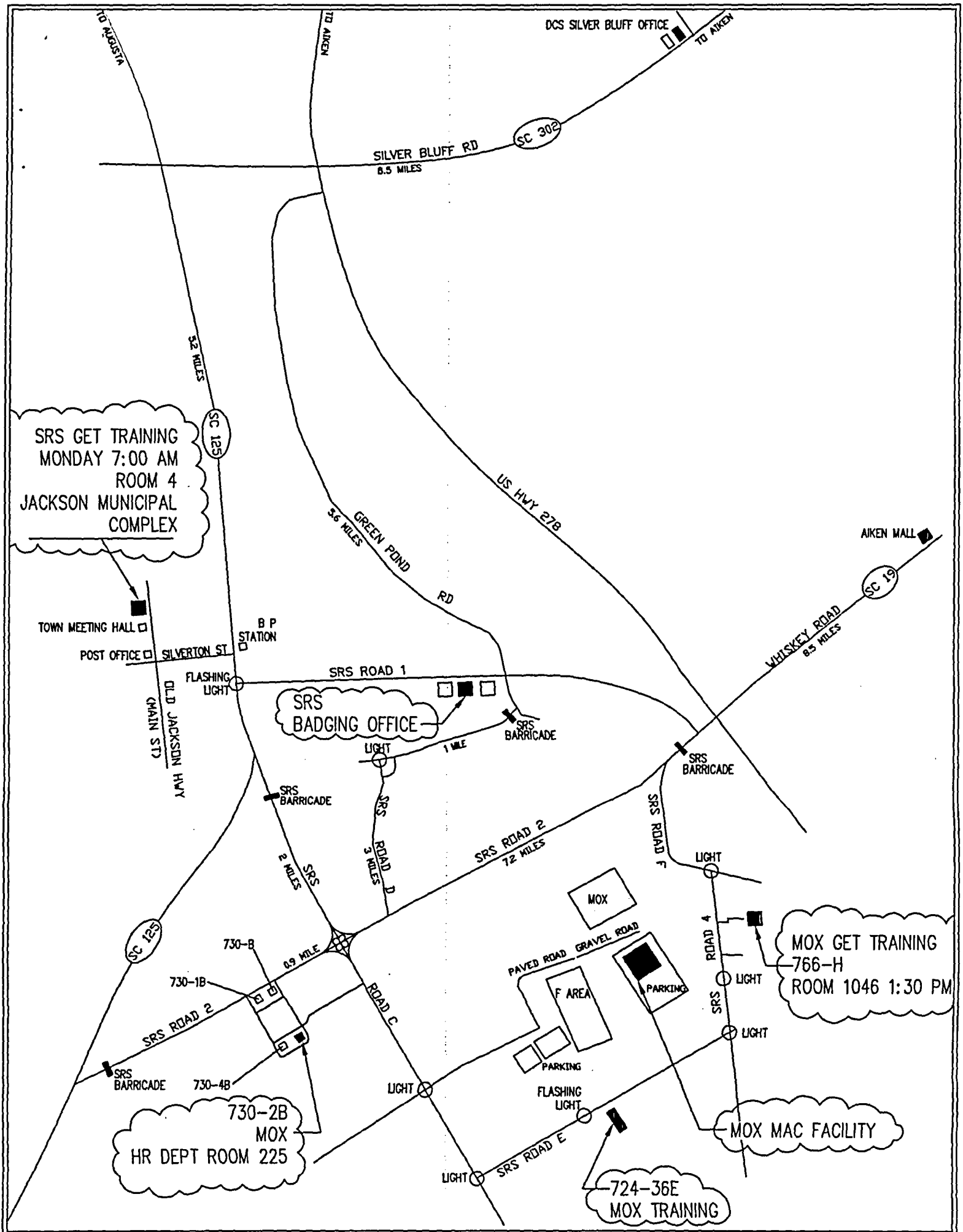

7. Unexpired Employment Authorization Card (Form I-688A)
8. Unexpired Reentry Permit (Form I-327)
9. Unexpired Refugee Travel Document (Form I-571)
10. Unexpired Employment Authorization Document issued by DHS that contains a photograph (Form I-688B)

1. Driver's license or ID card issued by a state or outlying possession of the United States provided it contains a photograph or information such as name, date of birth, gender, height, eye color and address
 2. ID card issued by federal, state or local government agencies or entities, provided it contains a photograph or information such as name, date of birth, gender, height, eye color and address
 3. School ID card with a photograph
 4. Voter's registration card

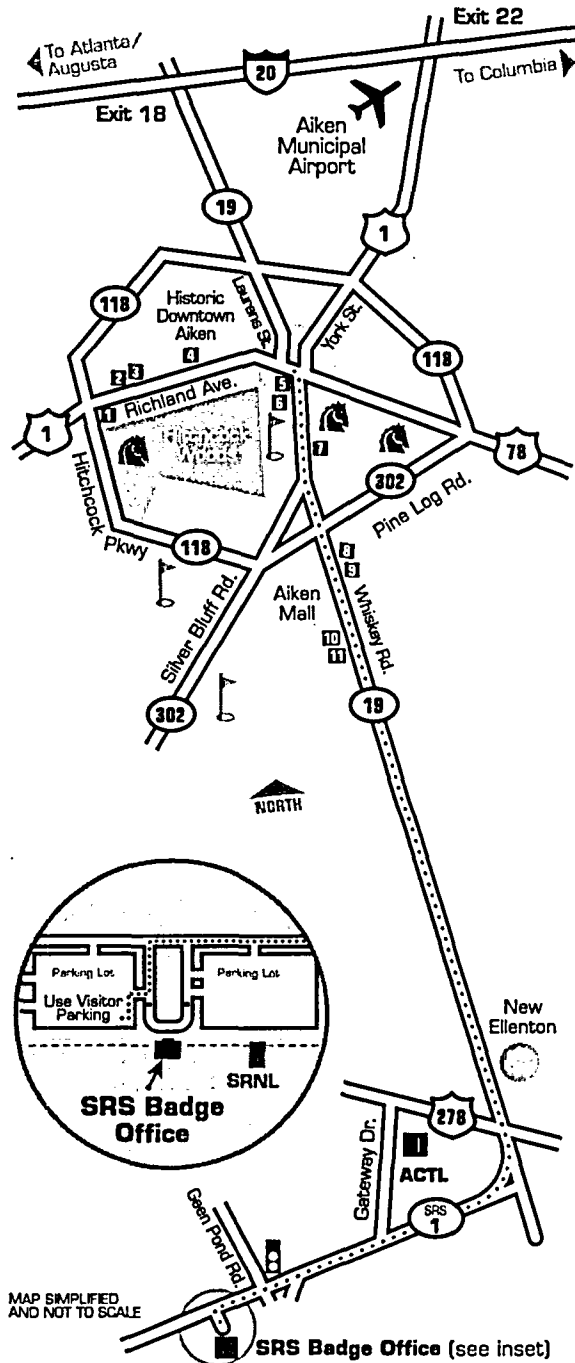

- Aiken - detailed map - pg. 2

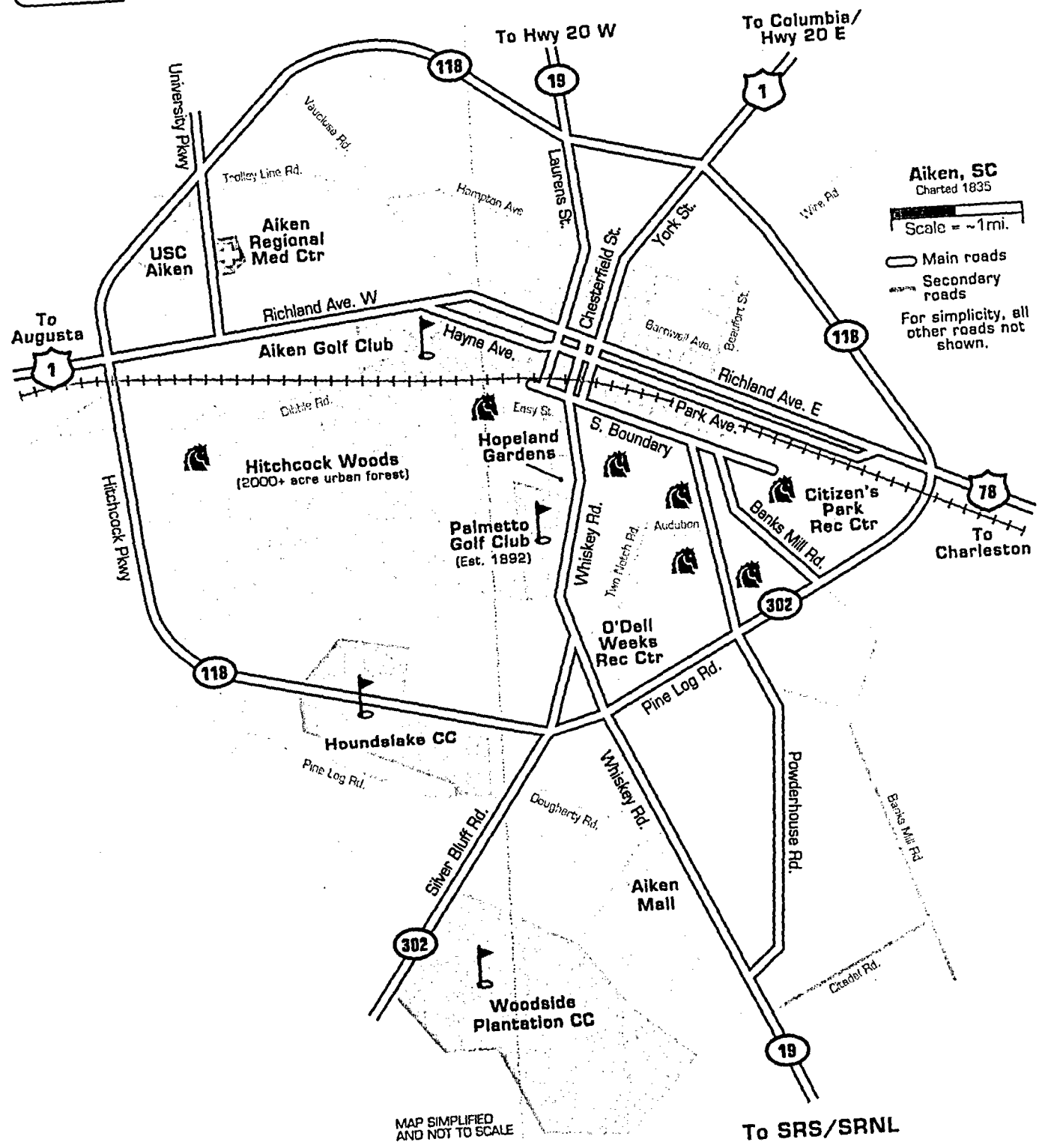
From Aiken to SRS/SRNL and Aiken County Technology Laboratory (ACTL)

- From the intersection of Richland Ave and Chesterfield St., turn south onto Chesterfield St. and continue south.
- Chesterfield St. becomes Whiskey Rd/Hwy 19
- Continue straight, Applebee's and Holiday Inn Express will be to your right in approx. 3.5 miles.
- Continuing straight for another 1.5 miles will put you at the intersection of Whiskey Rd. and Pine Log Road. You are now on the south side of Aiken, hotels and restaurants are available both north and south of this location.
- SRS/SRNL is straight ahead approx. 10 miles.
- After crossing Hwy 278, bear to your right onto Savannah River Site Road 1.
- For the ACTL, continue on SRS Road 1 for approx. 2.2 miles.
- Turn right onto Gateway Drive and travel approximately 1.4 miles
- ACTL is on right, behind the Research Center
- For SRS/SRNL, continue on SRS Road 1
- SRS/SRNL is on the left side of SRS Road 1 in approx. 2.4 miles beyond Gateway Drive. Just after the traffic signal at Green Pond Rd. (See the inset map for the Badge Office and parking).
- In most cases, you must first go to the Badge Office for access to either SRS or SRNL.
