To whom it may concern:

MWH Americas, Inc. (MWH) has been requested by Liberty Star Uranium & Metals Corp to gather information that would be helpful in their environmental due diligence and permitting efforts. National Environmental Policy Act documents and technical support information for the Arizona Strip project and any other recently permitted plans of operations for uranium mines in the AZ Strip area are requested. We are interested in access to mine plans of operation and correspondence between the US Bureau of Land Management (BLM) or the Nuclear Regulatory Commission (NRC) and the Arizona Strip project proponent as regards the permitting effort. The associated BLM project number for the Arizona Strip project is not known, but we understand that the proponent is Denison Mines Corp or International Uranium Holdings' Arizona Strip LLC.

We request scans/copies of any other environmental permits that were required or have been issued, i.e.

water quality information necessary for Aquifer Protection Permits, AZPDES permits, and Clean Water Act 404/401 permits.

We would prefer to have access to the files so as to review relevant documents rather than paying to copy/scan files that may not be relevant. Our fee category is commercial, and we would like to cap the scanning/copying costs at \$500. We would prefer to review files at the Phoenix BLM office. If we may be permitted to work with the agent that provides the copying services for NRC so as to acquire electronic copies instead of hard copies that would be preferable. We can supply a scanner capable of scanning large documents if that becomes necessary. If this is not acceptable please process this request so that we may receive hardcopies of such information.
