Reference is made to L-3's proposal dated January 31, 2007, as amended, March 14, 2007. This task order modification confirms the authorization provided to L-3 via e-mail dated, March 30, 2007, to commence work under this effort with a temporary cost ceiling not-to-exceed \$200,000.00;
2. Revise the labor hour requirements of Schedule A-1, for Years 6-9, (OPTIONS) under the task order to **add** the following position required for support to the NRC Consolidated Test Facility (CTF): One (1) Systems Engineer (Application: Integration - CTF). Reference is made to L-3's proposal dated January 31, 2007, as amended, June 20, 2007;
3. Revise the labor hour requirements of Schedule A-1, for Years 6-9, (OPTIONS) under the task order to **replace** the four (4) LAN Administrator (Function: Regional) positions with four (4) Junior Technicians and revise the functional description as follows:

From: Position: **Regional LAN Administrator**

Functions: Provides user specific support such as troubleshooting and solving software problems, and determining hardware problems (e.g., Printing, NIC cards, WordPerfect). Operates, monitors, installs, and administers servers, workstations, and printers, associated peripheral equipment, and network environment. Recognizes problems and requests assistance. Operates, monitors, installs, and administers Windows servers, E-mail

Servers, Backup devices, storage systems, workstations, printers, associated peripheral equipment, network appliances and network environment. Recognizes problems and requests assistance. Communicates effectively with end-users, technical support staff, and management.

As a result of this action, the LAN support hourly rate to the regions will increase by \$16.00 for Years 6 -7, \$17.00 for Year 8, and \$18.00 for Year 9. Reference is made to L-3's proposal dated January 31, 2007, as amended June 20, 2007 and July 26, 2007;

5. Revise the monthly price under years 6-9 (OPTIONS) of **Table 3 Schedule B-T1** for "Enterprise SW," Product Class PSESW12 and **Table 4 Schedule B-T2** for "Enterprise SW," Core Service Band CSBESW12 to reflect an **increase** of \$6.00 per seat (Est. Quantity: 4,200) due to the upgrade from Microsoft Office to the Microsoft Enterprise CAL (Client Access License). **The Enterprise CAL will provide the NRC with the Microsoft Professional Suite and the following key additional components necessary to support expanding needs of the NRC: Exchange Server Enterprise CAL, SharePoint Servier Enterprise CAL, Office Communications Server standard/Enterprise CAL, Windows Rights Management Services, Forefront Security Suite, and Operations Support.** Reference is made to L-3's proposal dated January 31, 2007, as amended June 20, 2007. This task order modification confirms the authorization provided to L-3 via e-mail dated, June 27, 2007, to commence work under this effort with a temporary cost ceiling not-to-exceed \$81,900.00;
6. **Add** Product Classes (PCBES and PCTX3SUPPORT) and Core Service Band (CSBBLKBERRY) for Blackberry Support (Est. Quantity: 200 Users) for Years 6-9 (OPTIONS) under the task order. This task order modification confirms the authorization provided to L-3 via e-mail dated, March 2, 2007, to commence work under this effort with a temporary cost ceiling not-to-exceed \$100,000.00. This modification also confirms the authorization provided to L-3 via e-mail dated, June 21 2007, to continue work under this effort with a temporary cost ceiling increase not-to-exceed \$50,000.00, thereby increasing the previous authorization from \$100,000.00 to \$150,000.00. Reference is made to L-3's proposal dated December, 1, 2006, as amended December 28, 2006;
7. **Add** Product Class (PCNP5) and Core Service Band (CSBNP5) for the HP 9040dn Black & White (B&W) Printer (Est. Quantity: 50) under the task order to support the NRC's Enterprise B&W printer needs for Years 6-9 (OPTIONS). Reference is made to L-3's proposal dated March 20, 2007, as amended, July 24, 2007;

8. Provide the labor and travel to allow for migration from the Novell GroupWise E-mail platform to Microsoft Exchange 2007/ Outlook 2007 as follows: (1) revise the labor hour requirements of Schedule A-1, for Years 6-7 (OPTIONS) under the task order to **add** the following positions: One (1) Senior Consultant- C&A Expert (Microsoft Consulting Services) and One (1) Windows Migration Consultant (Quest Consulting Services) and, **add** new Product Classes and Core Service Bands for the Microsoft Exchange 2007/Outlook 2007 efforts for Years 6-9 of the task order. **(Specifications are contained in Attachment 1)**. Reference is made to L-3's proposal dated May 25, 2007, as amended, July 10, 2007. This task order modification confirms the authorization provided to L-3 via e-mail dated, June 12, 2007 to commence work under this effort with a temporary cost ceiling not-to-exceed \$700,000.00;
9. **Add** Product Classes and Core Service Bands for the Storage Area Network (SAN) and Tape Backup Unit (TBU) for Years 6-9 of the task order. Reference is made to L-3's proposal dated, January 31, 2007. This task order modification confirms the authorization provided to L-3 via e-mail dated, March 30, 2007 to commence work under the SAN effort with a temporary cost ceiling not-to-exceed \$100,000.00, and e-mail dated, April 12, 2007 to commence work under the TBU effort with a temporary cost ceiling not-to-exceed \$100,000.00;

As a result of the above changes, the total estimated amount (ceiling) of the task order is revised as follows:
