SUBJECT: REPORT TO CONGRESS ON ABNORMAL OCCURRENCES:
FISCAL YEAR 2007

PURPOSE:

To obtain Commission approval to submit the Fiscal Year (FY) 2007 Abnormal Occurrence Report to Congress. This paper does not address any new commitments or resource implications.

BACKGROUND:

Section 208 of the Energy Reorganization Act of 1974 (Public Law 93-438) defines an “abnormal occurrence” (AO) as an unscheduled incident or event that the U.S. Nuclear Regulatory Commission (NRC) determines to be significant from the standpoint of public health or safety. The Federal Reports Elimination and Sunset Act of 1995 (Public Law 104-66) requires that the NRC report AOs to Congress annually. Enclosure 1 to this paper presents a draft of the “Report to Congress on Abnormal Occurrences: Fiscal Year 2007” (NUREG-0090, Vol. 30).

DISCUSSION:

The enclosed draft AO report describes five events at NRC-licensed facilities and six events at Agreement State-licensed facilities that meet the criteria to be classified as AOs. The first NRC-licensee event involved radiation exposure to an embryo/fetus. The other four NRC-licensee events were medical events, as defined in Title 10, Part 35, of the *Code of Federal Regulations*.

The most recent revision to the AO criteria was published in the *Federal Register* on October 12, 2006 (71 FR 60198) and became effective on that date.
