Dear Mr. Schwarz:

On February 12, 2008, the NRC staff completed its performance review of Palisades Nuclear Plant. Our technical staff reviewed performance indicators (Pls) for the most recent quarter and inspection results for the period from January 1 through December 31, 2007. The purpose of this letter is to inform you of our assessment of your safety performance during this period and our plans for future inspections at your facility.

This performance review and enclosed inspection plan do not include security information. A separate letter designated and marked as "Official Use Only – Security Related Information" will include the security cornerstone review and resultant inspection plan.

Overall, Palisades Nuclear Plant operated in a manner that preserved public health and safety and fully met all cornerstone objectives. Plant performance for the most recent quarter, as well as for the first three quarters of the assessment cycle, was within the Licensee Response column of the NRC's Action Matrix based on all inspection findings being classified as having very low safety significance (Green) and all Pls indicating performance at a level requiring no additional NRC oversight (Green). Therefore, we plan to conduct reactor oversight process (ROP) baseline inspections at your facility.

Additionally, the staff has identified a substantive cross-cutting issue in the area of human performance with a cross-cutting theme in the aspect of error prevention. There were 11 Green findings with a documented cross-cutting aspect in human performance. Four of the findings shared a common cross-cutting aspect of failure to use proper error prevention techniques (H.4(a)). In addition, these findings were from more than one cornerstone. Your staff has initiated actions to improve performance. This cross-cutting issue will remain open until the number of findings with the same cross-cutting aspect is reduced or when the NRC gains confidence your actions to address this adverse trend in human performance.
