Discussion

On May 5, 2008, at the request of NRC staff, a phone call was held to discuss the inclusion of Appendix 2.5 E in revision 4 of the Vogtle Early Site Permit ESP application. Appendix 2.5 E includes information required for both the COL and ESP reviews. Initially the NRC staff was in favor of removing most of this appendix, leaving only the information on the seismic input. After further review the staff concluded that other parts of the appendix would be required for the ESP review. SNC will propose a resolution. The compaction of the backfill adjacent to the Mechanically Stabilized Earth (MSE) wall was also discussed with SNC. Phase 2 of the test bed program will determine if uniform compaction can be achieved using different compaction equipment close to the wall than further away from the wall. The NRC staff also noted that SNC included a coefficient of friction between the mudmat and the backfill of .45. This differs from the Westinghouse AP1000 Design Certification value of .7. SNC used the site specific seismic values to recalculate the coefficient required for stability of the nuclear island. NRC staff will review this further.
