Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending May 23, 2008

Wolf Creek Generating Station (WCGS) Final Supplemental Generic Environmental Impact Statement

On May 8, 2008, the Division of License Renewal staff issued a Supplemental Environmental Impact Statement (SEIS) for the WCGS license renewal review. The SEIS represents the completion of the staff's environmental review of the license renewal application submitted by Wolf Creek Nuclear Operating Corporation (WCNOC). The SEIS was filed with the United States Environmental Protection Agency (EPA) for issuance of the Notice of Availability of the final SEIS in the *Federal Register*. The comment period expires in 30-days.

Performance Demonstration Initiative Meeting

During May 12 - 14, 2008, Division of Component Integrity (DCI) staff met with representatives of the Electric Power Research Institute (EPRI) - Performance Demonstration Initiative (PDI) to discuss the status of the EPRI-PDI program to implement the requirements of the American Society of Mechanical Engineers Code for ultrasonic testing (UT) qualifications. As noted in the April 28, 2008, Commission Briefing on reactor materials issues, UT examinations are a key aspect of degradation management. The Director of the DCI emphasized the importance of aggressively pursuing their efforts related to degradation management, inspection of dissimilar metal butt welds, and inspection of polyethylene pipe joints.

Steam Generator Task Force Meeting

On May 14, 2008, DCI staff conducted a Category 2 public meeting with the industry's Steam Generator Task Force to discuss various technical issues related to steam generator tube inspection and tube integrity activities under study by the industry. The issues discussed included industry activities associated with eddy current noise monitoring for tube inspections, steam generator divider plate integrity evaluation, handling of recent operating experience, and a possible proposal to revise technical specification requirements for tube inspections. The industry described schedules to provide several reports to the staff and plans to address several of the issues.

Steam Generator Tube Inspection Amendments Meeting

On May 14, 2008, DCI staff conducted a Category 2 public meeting with Nuclear Energy Institute (NEI) and licensee representatives to discuss pre-submittal information related to a technical specification amendment to reduce inspection scope for steam generator tubes in the tubesheet region for some steam generators. This meeting featured a discussion by the industry on their activities to address a list of staff questions related to their proposed technical approach. In addition, the staff was provided with an update on activities by an industry expert panel to address the staff's concerns. The staff expects additional meetings and interactions with the industry and the expert panel during the summer.

Crystal River Unit 3 - Planned Extended Power Uprate (EPU)

On May 19, 2008, the staff met with representatives of Progress Energy Florida and its contractor, AREVA, to discuss a planned submittal for an EPU application for Crystal River, Unit 3, currently scheduled for the third quarter of 2009. During the meeting, participants discussed the EPU and its integration with other major licensing actions/activities. Progress Energy is planning to implement the EPU during the 2011 refueling outage, which would raise its rated thermal power from 2069 MWt to 3014 MWt (~15.5%). Additional pre-application meetings on the EPU environmental report plan and technical discussions of the some of the EPU related licensing activities (e.g., core flood line break and secondary depressurization) are planned to be held in July 2008. Discussions on steam generator replacement and its impact on the EPU will be discussed in a separate meeting in August 2008.

Work Hour Rule Workshop

During May 19-20, 2008, the Division of Inspection and Regional Support (DIRS) and the Office of New Reactors staff participated in a NEI sponsored Work Hour Rule Workshop to discuss the recently published rule, 10 CFR Part 26, Subpart I, "Managing Fatigue." The staff provided guidance and clarification for licensees on the implementation of the requirements in the new addition to the rule. Meeting topics discussed included: NEI 06-11, "Managing Personnel Fatigue at Nuclear Power Reactor Sites," scheduling, training, managing hours, fatigue assessments, the waiver process, management systems, and planning for implementation. The staff gained insights on the challenges in implementing the rule, and additional issues were identified for clarification in the next revision of NEI 06-11.

Operator Licensing Biennial Review

During May 19-22, 2008, DIRS management and staff conducted a review of the administration of the operator licensing functions in the Region II office. DIRS conducts these biennial reviews to evaluate Regional consistency in implementing 10 CFR 55, the Examination Standards (NUREG-1021), and other associated policy guidance.

Region IV Counterpart Meeting

On May 22, 2008, the DIRS staff gave a presentation at the Region-IV Counterpart Meeting providing information on the Nuclear Reactor Regulation Operating Experience Program (OpE). The presentation, "A Day in the Life of OpE" includes a discussion of: OpE Activities; Technical Focus Areas; OpE Products; the OpE Smart Sample Program; performing OpE Searches; Quarterly OpE Summary reports, and OpE points of contact for assistance. This discussion provided a better understanding of the role of OpE in regional activities.

Detroit Edison's Reactor Technology Selection for the Fermi Combined License Application (COLA)

By letter dated May 16, 2008, Detroit Edison informed the NRC that there is no longer a need to withhold the reactor technology selection of the General Electric Hitachi Economic Simplified Boiling Water Reactor for the Fermi COLA. Currently, as indicated in Detroit Edison's letter dated November 12, 2007, the applicant is expected to submit the Fermi COLA in October 2008.

Meeting with the Tribal Council of the Timbisha Shoshone Tribe

On May 15, 2008, NRC staff met with the Tribal Council of the Timbisha Shoshone Tribe in Death Valley, California. Staff listened to the Tribe's concerns, questions and information needs with regard to Tribal participation in NRC's hearing process for deciding whether or not to authorize the proposed repository at Yucca Mountain. Staff discussed, in detail, the nature and scheduling of NRC's licensing and hearing process, and provided information on the steps necessary to certify compliance with NRC's requirements for the Licensing Support Network.

Phase 1 Decommissioning Plan for West Valley Demonstration Project Public Meeting

On May 19, 2008, NRC staff from the Office of Federal and State Materials and Environmental Management Programs (FSME), the Office of the General Council (OGC) and Region I met with the United States Department of Energy (DOE) to discuss the scope and content of DOE's Phase 1 Decommissioning Plan for the West Valley Demonstration Project. The public was invited to observe this meeting and had an opportunity to communicate with NRC staff before the meeting was adjourned.

40th Annual Conference of Radiation Control Program Directors Meeting

During May 19-22, 2008, Commissioner Peter B. Lyons, and Commissioner Kristine L. Svinicki were joined by NRC staff from FSME, the OGC, the Office of Nuclear Security and Incident Response (NSIR), Region I, Region III, and Region IV at the 40th Annual Conference of Radiation Control Program Directors meeting which was held in Greensboro, North Carolina.

Publication of Draft Regulatory Guide 3033 (DG-3033) "Standard Format and Content of Safety Analysis Reports for Uranium Enrichment Facilities"

On May 21, 2008, the subject draft regulatory guide was issued. The draft guide endorses the standard format and content for safety analysis reports and integrated safety analysis summaries described in the current revision of NUREG-1520, "Standard Review Plan for the Review of a License Application for a Fuel Cycle Facility", as a process that the NRC staff finds acceptable for meeting regulatory requirements. Office of Administration (ADM) Items of Interest Week Ending May 23, 2008

Peter G. Crane; Denial of Petition for Rulemaking (PRM-35-18)

On May 21, 2008, the NRC published a document (73 FR 29445) in the *Federal Register* that denied a petition for rulemaking (PRM-35-18) submitted by Peter G. Crane requesting that the NRC amend the regulations that govern medical use of byproduct material and the release of individuals who have been treated with radiopharmaceuticals. The petitioner requested that the "patient release rule" be partially revoked insofar as it allows patients to be released from radioactive isolation with more than the equivalent of 30 millicuries of radioactive iodine I-131 in their bodies. The NRC has denied the petition because it has determined that the issues raised in the petition do not justify a rule change.
