Dear Commissioners,

Thank you for sending me the Information Notice, License Renewal Application for 3

Mile Island Unit 1. I have a few concerns as I was an individual intervenor on the TMI#1

Restart Hearings. Although some of my concerns were answered at the time, many

contentions were not allowed in as being premature or not ripe. Here we have an

application for a license renewal for 20 years past the original operating lifetime.

I respectfully request that

1. a hearing be called upon this license renewal, and

2. I enter as a full intervenor with the following contentions and any other contentions

which grow from discovery of the NRC and the Licensee.

3. I also request that the Licensee be required to answer any discovery which touches

upon future plans such as dry cask storage and transportation of nuclear wastes.

4. I also request that past contentions which were answered with the knowledge of past

times be required to answer within the present knowledge. Specifically I request that the

TMI#2 Environmental Coalition on Nuclear Power Contention re Airplane Crashes be

revisited. I request that the NRC contact all intervenors whose contentions in the TMI#1 Restart

Hearings be contacted about this application as they have expertise and intimate concerns that

can be reopened by the present application. I request this as a matter

of fairness and aid to the licensing process.  
Inotherwords, the NRC will look better if you act fairly.  
At the time that the ECNP Contention was answered, there had never been a reinforced concrete skyscraper failing due to fire or an airplane crash. On September 11, 2001, buildings in NYC failed completely due to a fire in one case and 2 due to airplane crashes.  
Several of my contentions were also dismissed at the TMI#1 Restart Hearings due to the knowledge available at the time. One specifically concerned the vulnerability of specific groups like pregnant women and the fetuses therein. Considering the Institute for Energy and Environmental Research request for Executive Order dated by letter 2-20-2008, the basis for decision may very well change from 'Reference Man' to more vulnerable groups.  
I request that my previously dismissed contentions are allowed into the hearings for this TMI#1 License Extension Hearings.  
Further, electric power projections have been notoriously imprudent. With the present push for conservation and alternative energy, the electric power projections are suspect. I respectfully request that I be allowed a contention concerning need for this power and the costs.
