- NEF-08-00047-NRC, Submittal of Final Copies of the Proposed Financial Assurance Instruments for the Centrifuge Assembly Building and other Non Separation Building Modules.

On November 30, 2007 LES submitted a License Amendment Request (LAR-07-02) to the NRC to, among other things, request modification to Condition 15 of the Materials License (Ref. 1). The change allowed for phased funding of decommissioning costs and requested Condition 15 of the Materials License be broke into two parts. On March 14, 2008, the NRC issued Amendment 6 to LES's Materials License approving the requested change (Ref. 2). Part (a) of Condition 15 requires LES to provide proof of \$5 million liability insurance as required under 10 CFR 140.13b at least 30 days prior to the planned date for obtaining test material (≤50 kg of natural or depleted UF₆).



As stated in a letter from LES to the NRC (Ref. 3), among other things, LES plans to obtain test material on or about September 16, 2008 in preparation for Hot Acceptance testing in the Centrifuge Assembly Building at the NEF.

On April 22, 2008, LES received approval from American Nuclear Insurers to increase the limit of liability to \$5 million dollars effective August 1, 2008. The approval is attached as enclosure 1.

ANI agrees to increase the limit of liability, under Facility Form Policy NF-0350, from \$1,000,000 to \$5,000,000. The increase will be effective on August 1, 2008, and reflects the licensing needs of Louisiana Energy Services for the National Enrichment Facility.

In offering a limit of \$5,000,000, we assume that any requisite radiation protection programs will be in place before nuclear material first arrives at the National Enrichment Facility. Please let me know if you have any questions.
