FINANCIAL ASSURANCE DOCUMENTS, CONTROL NO. 141759

Dear Mr. Lanier:

This is in reference to your letter dated January 9, 2007 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 07-28386-01. A recent NRC audit of your financial assurance documents has identified that we need the following additional information:

1. Please submit a Decommissioning Funding Plan (DFP) in accordance with the Guidance in NUREG 1757, Vol. 3, Appendix A.3. Your letter of January 9, 2007 refers to a reassessment of the cost but the documentation showing how you derived that cost in accordance with NUREG-1757, Vol. 3 was never submitted. The 1995 Decommissioning Funding Plan does not meet the guidance outlined in Appendix A.3, pages A-25 to A-42. Your DFP should include the tables as outlined in Appendix A.3.
2. Depending upon the Cost Estimate derived from the DFP, please revise and submit a Letter of Credit, a Standby Trust Agreement, and a Certification of Financial Assurance. Please ensure that your legal names and business address of your company as listed on the current NRC license is reflected in the appropriate place on each financial assurance document. For example, see Section A.2.4 Model Certification of Financial Assurance in NUREG 1757, Vol 3., Appendix A, page A-23. We noted that documents submitted with the January 9, 2007 letter stated Johnson Matthey, Inc., rather than Tracerco, a business unit of Johnson Matthey, Inc., as stated on your license.

We will continue our review upon receipt of this information. Please reply within 30 days of the date of this letter to my attention at the Region I Office and refer to Mail Control No. 141759. If
