Recommendation 5:	Re-certify and re-accredit the NRC Data Center/Telecommunications System (DC/T).
Status Dated April 24, 2008:	The Data Center and Telecommunications systems have been split into two separate systems. The Data Center Services system was certified on September 27, 2007. Due to the Office of Information Services (OIS) limited resources and higher priority accreditation efforts; OIS anticipates the Data Center Services accreditation by June 30, 2008. OIS anticipates the Telecommunications System accreditation in the 2nd quarter FY 2009.
OIG Response:	The proposed actions address the intent of the recommendation. This recommendation will be closed when OIG reviews a copy of the accreditation.
Status:	Resolved.

Recommendation 7:	Re-certify and re-accredit the Emergency Response Data System (ERDS).
Status Dated April 24, 2008:	The certification and accreditation of ERDS was completed on February 1, 2008. The Authority to Operate memo (ML080230212) is available in ADAMS. We request this recommendation be closed.
OIG Response:	The corrective action fulfilled the intent of OIG's recommendation. OIG reviewed the accreditation documentation and determined that it met the agency's criteria for issuing an Authority to Operate memorandum. This recommendation is therefore closed.
Status:	Closed.

Recommendation 8:	Re-certify and re-accredit the Emergency Telecommunications System.
Status Dated April 24, 2008:	Based on a change in priorities for systems, the anticipated date for full certification and accreditation of the Operations Center Information Management System (OCIMS) system is third quarter FY 2008.
OIG Response:	The proposed corrective action addresses the intent of the recommendation. This recommendation will be closed when OIG reviews a copy of the accreditation.
Status:	Resolved.

Recommendation 10:	Update the NRC Local Area Network/Wide Area Network (LAN/WAN) Business Continuity Plan.
Status Dated April 24, 2008:	Due to limited OIS resources and higher priority accreditation efforts, OIS anticipates the LAN/WAN system business continuity testing will be completed by June 30, 2008.
OIG Response:	The proposed corrective action addresses the intent of the recommendation. This recommendation will be closed when OIG reviews a copy of the updated Business Continuity Plan.
Status:	Resolved.
