To Whom It May Concern:

Baker Hughes Oilfield Operations Inc, dba Baker Atlas, hereby submits this request for a renewal and minor amendment to specific Export License CBP4b-2, issued pursuant to 10 CFR Part 110, to allow the export and import of Americium 241 Beryllium byproduct material that meets the encapsulated specifications of a Special Form Oil Well Logging source.

As indicated on the enclosed NRC Form 7, we would like to renew the license with all currently approved countries and locations to remain the same. The minor amendment requested with this renewal application is a legal entity name change for the location in Nigeria. The physical location shall remain the same. This is a legal entity name change only that is warranted due to license requirements of the government of Nigeria.

As part of our current agreement, all sealed sources will remain in the custody of either Baker Hughes Oilfield Operations, Inc or its foreign affiliate(s) at all times and will be stored in a secure facility controlled either by Baker Hughes Oilfield Operations, Inc. or its foreign affiliate(s) when not in use.
