TVA's application for a license for its proposed Bellefonte project includes several pages of financial information that TVA claims are "proprietary." These include pages 1.1-6 through 1.1-12 of its application, encompassing parts 1.3.1 through 1.3.4 and tables 1.3-1 through 1.3-4.

Please inform me as to whether the NRC has accepted TVA's assertion that some portions or all of these documents are "proprietary," and, if not, when they, or some portions of them, will be released to the public.

In addition, if NRC has accepted TVA's assertion, please explain how an agency wholly owned by the United States government, as TVA acknowledges it is, may have financial information withheld as "proprietary."
