Subject: NRC Review of TVA's Bellefonte COL application

The Nuclear Regulatory Commission has begun the review of the Combined Operating License (COL) application for Bellefonte Nuclear Plant, Units 3 & 4 in Northeastern Alabama. A copy of the COL application including the Environmental report can be found at <http://www.nrc.gov/reactors/new-licensing/col/bellefonte.html>. Note that the NRC environmental review team is planning to visit the proposed plant site during the week of March 31, 2008. EPA and NRC management have agreed that we should inform you and involve your regional staff in the COL reviews at the earliest opportunity.
