Thanks for speaking to me while you were on the road. As I mentioned in our call, I've had an opportunity to review the list you provided and it would be a great help if you could point out which persons on the list have environmental focus in their work.

The discussion will be an opportunity for the NRC to provide the slide presentation planned for the evening public meeting to officials of Cherokee County. During the morning's discussion we will 1.) explain the NRC environmental scoping process as it relates to the National Environmental Policy Act (NEPA); 2.) provide officials an informal opportunity to ask questions concerning the NRC process as it relates to NEPA; and 3.) explain the objectives of the evening meeting so that participating officials can provide insights regarding the environmental issues that are important to the community. The NRC staff seeks to enhance public participation in the environmental scoping process in a meaningful manner. While other issues involving safety and security are important to the NRC and will be considered in the safety review, the environmental scoping process is focused on those issues affecting the human environment including radiological effects, ecological effects, socioeconomic effects, and effects on the physical environment.

Therefore, as I mentioned above if you could point out which officials have an environmental focus in their positions, then those are the officials that would most likely benefit from the discussion. Thank you again for your help in this effort.
