Enclosed is the application for renewal of the GSA/FPRS, Office of National Defense Stockpile, NRC License Number STC-133. This application was prepared in accordance with the information outlined in 10 CFR part 40, NRC Form 313, and the NRC Regulatory Guide 10.4(FC-409-4). Several enclosures have been included and identified by the item number on NRC Form 313, to which they apply.

Several internal organizational changes have resulted in the renaming ofour Service from GSA/FPRS, Office of Stockpile Management (DMC) to GSA/FPRS, Office of National Defense Stockpile (DN). Please note item 2 on NRC Form 313.

Enclosure No.1 (Ref. item 3 NRC Form 313) contains an up to date inventory and locations of all licensed material in the National Defense Stockpile. One location (Griffis Air Force Base, Rome, New York), no longer appears on this inventory. All previously stored licensed material at this location has been relocated to GSA/FPRS Scotia Depot, Scotia, NY. Enclosure No.5 contains the closeout survey for Griffis Air Force Base.

Enclosure No. 3 Lists the individuals responsible for Radiological Safety and Monitoring nationwide. (Ref. Item 7 NR Form 313)

Enclosure No.4 addresses our training requirements for individuals responsible for radiological safety and monitoring nationwide and our future plans to stay current with NRC proposed rules and requirements.

Enclosure No.5 is the closeout survey for Griffis Air Force Base, Rome, New York. This survey shows that the area where licensed material was previously stored is free of contamination. The Tungsten (Wolframite) Lots P2627, P2646, P2651-A and P2651-B have been relocated to the GSA/FPRS Scot Depot, Scotia, NY.

These explanations and enclosures reflect the principle changes which have occurred in our Radiological Program covered by the expiring license. All other information submitted for the previous license continues to be in effect and accurately represents our present Radiological Program.
