### NRC SEEKS COMMENT ON PROPOSAL TO SET REQUIREMENTS FOR SECURITY CHECKS ON STAFF AT RESEARCH REACTORS

The Nuclear Regulatory Commission is seeking public comment on a proposal to draft a rule formalizing requirements for U.S. research and test reactors (RTR) to perform fingerprint-based background checks on staff with unescorted access to their facilities.

The proposal would implement requirements of the Energy Policy Act of 2005, making permanent measures now imposed by NRC Orders issued in 2007. RTR licensees must ensure people allowed unescorted access to the facilities, or people requesting such access, are fingerprinted and undergo a criminal history check by the Federal Bureau of Investigation. The proposal would draft a rule requiring any current or future RTR licensee to ensure that individuals granted unescorted access to risk-significant areas and risk-significant materials at the facilities are subject to an FBI fingerprint-based criminal history record check or an acceptable alternative.
