H* Meeting with Industry

On April 3, 2009, a public meeting was held with the industry to discuss the technical basis for limiting the scope of steam generator tube inspections in the tubesheet region of certain Westinghouse designed steam generators. Significant progress has been made over the last 15 months in addressing NRC staff issues with the original proposal.

Point Beach Units 1 and 2 Extended Power Uprate (EPU) Application

By application dated April 7, 2009, the licensee requested a 17% EPU for Point Beach Units 1 and 2. The application requests NRC approval by April 7, 2010. NRC's standard review time for an EPU is 12 months after NRC's acceptance of the application. The licensee indicated that they followed the guidance in NRC Review Standard (RS)-001, "Review Standard for Extended Power Uprates" in developing its application. The NRC staff will be conducting an acceptance review of the application.

Issuance of the Renewed Operating License for Oyster Creek Nuclear Generating Station

On April 8, 2009, the operating license for the Oyster Creek Nuclear Generating Station, located in Lacey Township, New Jersey, was renewed authorizing operation for an additional 20 years. The new license expiration date is April 9, 2029. AmerGen Energy Company, LLC, a subsidiary of Exelon Nuclear Generation Company, LLC, submitted the license renewal application to the NRC on July 22, 2005. The staff completed the safety review as documented in the safety evaluation report, NUREG 1875, Volumes 1 and 2, dated April 30, 2007, and the safety evaluation report supplement, NUREG 1875, supplement 1, dated September 30, 2008. The staff's environmental review is documented in the supplemental environmental impact statement, NUREG 1437, supplement 28, dated January 31, 2007.

Oyster Creek is the 52nd reactor license renewed by the NRC. Thirteen other applications are under review.
