Spring Meeting of the Nuclear Waste Technical Review Board

On June 11, 2009, staff observed the spring meeting of the Nuclear Waste Technical Review Board (Board) in Las Vegas, Nevada. The Board heard presentations and discussed high-level waste topics on (1) inventory projections (2) alternatives to disposal other than at Yucca Mountain, Nevada, and (3) research and data needs for very long-term dry storage of spent nuclear fuel. Participants included representatives from the Department of Energy, State of Nevada, Nuclear Energy Institute, Congressional Research Service, Electric Power Research Institute, Transnuclear, Inc., and Dominion Power Company.

European Institutes Information Exchange on High-Level Waste Management

From May 30 to June 6, 2009, staff visited four European research institutes. The staff met with technical experts in the studies of nickel-based alloy corrosion, waste form performance, and radionuclide behavior under geologic repository conditions. The waste forms discussed included high burn-up spent nuclear fuel and high-level waste glass. The goals of the meetings were to obtain new data and exchange views on issues related to this data. The visits were with: Commissariat à l'énergie Atomique, France; Nuclear Research Center, Belgium; and Institute für Nukleare Entsorgung and Institute for Transuranium Elements, Germany.

Region IV Nuclear Materials Program Evaluated

On June 15, 2009, the Management Review Board met to consider the findings of the Region IV Integrated Materials Performance Evaluation Program review. The Region's nuclear materials program was found satisfactory for all indicators reviewed. Overall, the Region was found adequate to protect public health and safety.

Uranium Milling Requirements Discussed

On June 15, 2009, FSME staff met with U.S. Environmental Protection Agency (EPA) staff to discuss EPA's plans to broadly revise 40 CFR 192. 40 CFR 192 provides the standards for NRC's Part 40, Appendix A, uranium milling requirements. After 40 CFR 192 is finalized, NRC will conform its regulations on groundwater protection for In Situ Recovery facilities, to meet the revised 40 CFR 192 standards. EPA plans to publish the proposed rule in early 2011.

Knowledge Management: Tools and Methods

On June 9 and 17, 2009, staff from the Information and Records Services Division's Knowledge Management Working Group offered an Information Series workshop entitled *Knowledge Management: Tools and Methods*. This workshop was hosted by the Records and Archives Services Section (RASS). Discussions were held on the status of the records program and the goals it shares with knowledge management. RASS also covered records management methodologies that can apply to knowledge management and showcased the Records Management Toolkit which was presented by staff from the National Archives and Records Administration (NARA).

IRSD Staff Member Attends Special Libraries Association Centennial Conference

On June 15 – 17, 2009, staff from the Information and Records Services Division attended the Special Libraries Association Centennial Conference which was held in Washington, DC. Sessions were held on digitization projects, using Taxonomies in SharePoint databases, measures toolkits for librarians, and a poster session on library marketing. The opening Session keynote speaker was former U.S. Secretary of State Colin Powell.

Biennial Review of Agency Contracts

On June 16, 2009, the Information and Records Services Division completed the biennial review of agency contracts that provide for the operation of a Privacy Act system of records (any activity associated with the maintenance, collection, use, and/or dissemination of Privacy Act records), as required by the Office of Management and Budget Circular No. A-130. This review looked at a random sample of Nuclear Regulatory Commission contracts to ensure that the wording of each makes the provisions of the Privacy Act binding on the contractor and their employees by including by reference Federal Acquisition Regulation (FAR) clauses 52.224-1, Privacy Act Notification, and 52.224-2, Privacy Act. Of the 23 agency contracts reviewed this year, three required an administrative modification to incorporate the required FAR clauses. A summary report of this review is in the Agencywide Documents Access and Management System (ML091670242).

Controlled Unclassified Information (CUI) Council - Working Group

On June 16, 2009, staff from the Information and Records Services Division participated in a working group of the CUI Council at the NARA, which is the Executive Agency for implementing the Federal-wide CUI framework. The purpose of the meeting was to again discuss and further develop the specified dissemination instructions for information that is not releasable to foreign nationals and to begin discussion on the specified dissemination instructions for intellectual property. The goal of writing the specified dissemination instructions is to standardize them so all agencies can use one specified dissemination instruction. The next meeting of this working group will be on June 30, 2009, to review the draft instruction for intellectual property and begin discussion on the instruction for legal information.
