Jerry,

The submittal was rejected because the PDFs failed to meet NRC requirements as specified in the **REASON FOR REJECTION** section and the tiff files also needed to be converted to PDFs. These are "must fix" reasons in order for the submittal to be processed. We recommend that the .zip files should be unzipped into folders.

Some of the acceptable, non-PDF files are input/output data file, which we don't process and/or reject. We noticed the disk has .ace file which we weren't certain about, only because the extension is similar to other archival compression format. If this file is truly a data file, then it can be left as is...no correction necessary.

If you need the files to complete the technical analysis of the application, I suggest you ask Detroit Edison for a Reviewer/courtesy copy, like other PMs. But in order to have this submittal processed into ADAMS, it must comply like other submittals. Including the statement below is OK and applies to non-PDF files such as input/output data files, but not OK for PDF files to be declared OARs. Contact me if you have any questions.

Detroit Edison states the following in their cover letter:

"The file format and names on the enclosed CDs do not comply with the requirements for electronic submission in the NRC Guidance Document, "Guidance for Electronic Submissions to the NRC." The NRC Staff requested the files be submitted in their native formats required by the software in which they are utilized to support NRC review of the COLA."

The Agency requested the file formats because they are needed to complete the technical analysis of the application. The information on the disks would be virtually useless to the tech staff in any other format. The original disks should be maintained in a manual, hardcopy record keeping system, which I am sure is possible, as additional copies of the data files may be needed in the future. If you are not able to comply with this request, please notify me and I will move this issue on to senior management for resolution.

Please have submitter convert tiff files to PDFs and while correcting the pdf files, could you also please have the submitter unzip the .ZIP files, placing the unzipped files into a folder.

Also, please note .ace files are not permitted and cannot be processed and please do not include duplicate files but be sure that the single file is in PDF format.

Please contact the licensee to obtain new CD(s) that is accessible with PDF's that conforms to the document submittal guidance that is listed on the external NRC website. I'm sending back to you, **Jerry Hale**, the whole package. Please send the resubmittal package down to me to process @ OP1-36. If you have any questions, feel free to contact me at x6781.
