 - a. The information sought to be withheld from public disclosure is owned by PPL Bell Bend, LLC, its affiliates or third parties to whom PPL Bell Bend has an obligation to maintain its confidentiality and has been held in confidence by PPL Bell Bend, LLC.
 - b. The information sought to be protected is not available to the public to the best of my knowledge and belief.
 - c. The information is of the type that would customarily be held in confidence by PPL Bell Bend, LLC. The information that PPL Bell Bend, LLC is requesting to be withheld from public disclosure are elements of PPL Bell Bend, LLC's acquisition of exclusion authority within the projected Exclusion Area Boundary for the Bell Bend Nuclear Power Plant. PPL Bell Bend, LLC limits access to these elements to those with a "need to know" subject to maintaining confidentiality.
