GDC 5 applies at multi-unit sites, but neither AP1000 nor ESBWR are multi-unit in their DC reviews. I will forward you the writeup when I get it. We are planning to discuss at DCWG, I believe.

We may also make changes to the submittal process so that the one-pagers get into the right docket files through our normal processes.

I will not be at the DCWG, I'll be on the west coast at the APPA conference.

Your v-mail greeting says that e-mail would work better for you this week.

At last Tuesday's meeting with the New Plant Working Group, Dave described a new NRO process for Directors/Deputies to meet regularly to resolve new plant issues that are stuck or need timely resolution. This process was also discussed with AP1000 folks the day before. It was explained that industry (DCWGs or for generic issues, NEI) could provide brief white papers as input to these discussions on significant issues. We also got the message that the bar for us to exercise this process should be set high.

Re: process, you were mentioned as a possible point of contact for receiving issue papers from the industry. I think that having you as the single point of contact is a good idea, and I wanted to confirm that plan with you. Also, I wanted to ask you about how you envision closing the loop with whomever submitted an issue after it is discussed by the NRO Directors.

As discussed last week, we think that the current issue about applicability of GDCs to offsite power systems qualifies for special attention, and we are working on a short issue paper to input to the process.

Please advise regarding the process aspects. Thx.
