Public Outreach Meeting in Support of the Victoria County Station Early Site Permit (ESP) Application

On April 15, 2010, NRC staff held a Category 1 public meeting at the Victoria Community Center Dome, located in Victoria County, Texas. The purpose of the meeting was to inform members of the public of the NRC review process as well as when and how they may participate in the review process for the Victoria County Station, ESP application that Exelon submitted to the NRC on March 25, 2010. The ESP application uses the plant parameter envelope approach and no limited work authorization has been requested at this time. The acceptance review is ongoing and is scheduled to be completed on June 7, 2010.

Draft Environmental Impact Statements (DEISs) Issued for Calvert Cliffs and V.C. Summer

On April 16, 2010, the staff issued the DEISs for Calvert Cliffs Nuclear Power Plant, Unit 3 (NUREG-1936), and for V.C. Summer Nuclear Station, Units 2 and 3 (NUREG-1939), for public comment. A 75-day public comment period began on April 23, 2010, for these DEISs when the Notice of Availability of each DEIS was published by the U.S. Environmental Protection Agency. The staff has scheduled public meetings on May 25, 2010, in the vicinity of Calvert Cliffs and on May 27, 2010 in the vicinity of V.C. Summer to present its analyses and to accept public comments on the respective DEISs. The staff's preliminary recommendation to the Commission related to the environmental aspects of each proposed action is that combined licenses be issued as requested.

Environmental Law and Policy Conference Panel on Nuclear Waste

On Friday, April 16, 2010, NMSS staff attended a panel discussion, "U.S. Nuclear Waste Law and Policy: Fixing a Bankrupt System," as part of the Environmental Law and Policy Annual Review Conference. The conference, co-sponsored by the Environmental Law Institute and Vanderbilt University Law School, is held annually on Capitol Hill, and attended mostly by Congressional staff members. Speakers included the author of the subject Law Review article (<http://www.breakingthelogjam.org/CMS/files/29721229374284StewartMacro.pdf>), Richard B. Stewart, Professor, NYU School of Law; Vice Admiral, John J. Grossenbacher (*Ret.*), Director, INL; Geoffrey H. Fettus, Senior Attorney and Dr. Thomas B. Cochran, Senior Scientist, both of Natural Resources Defense Council; and David R. Hill, Partner, Sidley Austin LLP.

The subject article was written in 2008 before recent actions to shut down the Yucca Mountain Project. All of the panelists noted that informed consent of the host state and community will need to be a part of any new process, and most seemed to be of the mind that the U.S. Department of Energy was not well suited to site and manage a repository or centralized storage facility. Several also voiced skepticism that the newly-formed Blue Ribbon Commission would be able to "solve the problem" in the limited time available to it, noting that the source of the current problems with the national program rested, in part, with the long timeline for implementation along with issues of adequacy of the institutions and governance. In addition, most panelists voiced skepticism toward future reprocessing facility licensing, citing economics as a barrier for industry.

Categorical Exclusions from Environmental Review, Final Rule, 10 CFR Part 51  
(RIN 3150-AI27, NRC-2009-0269)

On April 19, 2010, the U.S. NRC published a final rule (75 FR 20248), amending its regulations that describe the categories of actions which do not require an environmental review under the requirements of the National Environmental Policy Act of 1969, as the NRC has determined that such actions do not individually or cumulatively have a significant effect on the human environment. The amended regulations eliminate the need for the preparation of environmental assessments for NRC actions that are minor, administrative, or procedural in nature. The amendments do not change any requirements for licensees, but may provide for more time for NRC action on more substantial issues and/or speed up the process for review of the amendments. The final rule was effective on April 19, 2010.

Letter to be Signed by EDO

On April 21, 2010, the Executive Director for Operations signed a letter to Mr. Sherwood Martinelli informing him that his correspondence does not meet the acceptance criteria for a petition for rulemaking. In his correspondence, Mr. Martinelli requested that the NRC promulgate a regulation that provides specific weight-based exposure limits for household animals and pets. He also requested that a fund be established for family members of cancer victims (both human and animal) who live within 10 miles of nuclear reactors, with funds to be provided by licensees. Mr. Martinelli's request does not meet the NRC's acceptance criteria for a petition for rulemaking because the NRC does not have authority under the Atomic Energy Act of 1954, or any other law, to assess fees against licensees for the purpose of establishing a fund to compensate family members for the loss of humans or animals due to radiation exposure. However, Mr. Martinelli's proposal for the NRC to develop weight-based exposure limits may meet the NRC's acceptance criteria for a petition for rulemaking. Mr. Martinelli has 90 days to meet the criteria. The letter to Mr. Martinelli can be found in ADAMS at ML100700072.
