Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending May 21, 2010

Public Meeting on Multiple Spurious Operation Resolution

On May 13, 2010, the staff held a Category 2 public meeting with the Nuclear Energy Institute (NEI) to discuss multiple spurious operations resolution, industry approach to compensatory measures under EGM 09-002, "Enforcement Discretion for Fire Induced Circuit Faults," clarifications or adjustments to NEI 00-01, "Guidance for Post-Fire Safe Shutdown Circuit Analysis," and to Regulatory Guide 1.189, "Fire Protection for Nuclear Power Plants," and Direct Current Circuit Testing.

<u>Public Meeting with University of Maryland (UMD) Regarding License Renewal for the Maryland University Training Reactor</u>

On May 17, 2010, the staff held a Category 1 public meeting with the UMD at NRC Headquarters. The purpose of the meeting was to discuss delays in the review of the License Renewal Application for the Maryland University Training Reactor (MUTR) and to formulate a path forward for the timely completion of the review. The meeting participants represented NRC, UMD (the licensee of MUTR), and members of the public including other Test, Research and Training Reactors. NRC and UMD agreed that frequent communications were essential in expediting the processing of the application. A schedule for submission of financial Requests for Additional Information (RAIs) and for moving ahead on technical RAIs was reached.

<u>Public Meeting with Catawba and McGuire Regarding Generic Letter 2004-02, Pressurized Water Reactor Sump Performance</u>

On May 17, 2010, the staff held a public phone conference with the licensee for Catawba and McGuire to discuss the licensee's revised head loss testing protocol intended to respond to an NRC staff request for additional information regarding Generic Letter 2004-02, "Pressurized Water Reactor Sump Performance."

<u>Public Meeting with Kewaunee Regarding Generic Letter 2004-02, Pressurized Water Reactor Sump Performance</u>

On May 20, 2010, the staff held a public phone conference with the licensee for Kewaunee to discuss the licensee's planned responses to an NRC staff request for additional information regarding Generic Letter 2004-02, "Pressurized Water Reactor Sump Performance."

On May 12, 2010, NMSS staff had a quarterly management meeting with AREVA Enrichment Services (AES) to discuss management issues and project status related to AES's application for the Eagle Rock Enrichment Facility. AES provided an update on the project status including organization changes and schedule highlights. This was a Category 1 meeting and the public was invited to observe this meeting and had an opportunity to ask questions after the business portion of the meeting was completed.

<u>Publication of NUREG/CR-7011, "Evaluation of Treatment of Effects of Debris in Coolant on Emergency Core Cooling System and Containment Spray System Performance in Pressurized Water Reactors"</u>

NUREG/CR-7011, "Evaluation of Treatment of Effects of Debris in Coolant on Emergency Core Cooling System and Containment Spray System Performance in Pressurized Water Reactors and Boiling Water Reactors," was published May 12, 2010. This report identifies disparities in the regulatory treatment of emergency core cooling system suction strainer performance between boiling-water reactors and pressurized-water reactors, evaluates the technical significance of the differences, and provides recommendations on the path forward for handling the disparities.

Publication of Regulatory Guide (RG) 6.7, Revision 2, "Preparation of an Environmental Report To Support a Rulemaking Petition Seeking an Exemption for a Radionuclide-Containing Product."

On May 17, 2010, the staff published a RG that provides general procedures for the preparation of environmental reports (ER) that are submitted to support a rulemaking petition for an exemption for a radionuclide-containing product. It replaces Revision 1 of RG 6.7, issued June 1976. Use of this RG will help to ensure the completeness of the information provided in the ER, assist the staff of the NRC and others in locating pertinent information, and facilitate the environmental review process. RG 6.7 available on the NRC website at http://www.nrc.gov/reading-rm/doc-collections/req-guides/products/rg/.

<u>Publication of Draft Regulatory Guide 3039 (DG-3039) "Standard Format and Content for Emergency Plans for Fuel Cycle and Materials Facilities."</u>

On May 19, 2010, the staff issued DG-3039 to provide an opportunity for public comments. The DG is proposed Revision 1 to RG 3.67, which provides guidance acceptable to the NRC staff on the information to be included in emergency plans and establishes a format for presenting the information. Use of a standard format will help ensure uniformity and completeness in the preparation of emergency plans. DG-3039 is available on the NRC website at http://www.nrc.gov/reading-rm/doc-collections/reg-guides/fuels-materials/draft-index.html.

Integrated Source Management Portfolio (ISMP)

On May 11, 2010, as a result of a competitive acquisition, a contract (NRC-41-10-017) was awarded to Lockheed Martin Services, Inc. in Gaithersburg, Maryland, to provide contractor support for the planning, acquisition, system certification, development, deployment, hosting, and maintenance of NRC's ISMP project. The portfolio is composed of automated tools for credential tracking (license and certificate), inspection tracking, item tracking (devices and sources), and license verification. The portfolio consists of three systems: (1) the National Source Tracking System, (2) the Web-Based Licensing System, and (3) the License Verification System. The period of performance is from May 11, 2010, through May 10, 2011, with an additional nine 1-year options. The total value is \$77,439,634.37, inclusive of all options.

Independent Validation and Verification (IV&V)

On May 18, 2010, as a result of a competitive acquisition, Blanket Purchase Agreements (BPA) (NRC-DR-33-10-324 and NRC-DR-33-10-323) were awarded to Aegis, Inc. in Merrifield, Virginia, and Portfolio Management Consulting (PMC), LLC in Lake Ridge, Virginia respectively, to provide IV&V services across the agency. Task orders will be competed between the two BPA holders in order to gain best value for the NRC. The period of performance is May 18, 2010, through May 17, 2015. The maximum ordering dollar amount is \$84,000,000.00 for Aegis and \$68,000,000.00 for PMC.
