Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending June 18, 2010

Meeting with Industry's Materials Reliability Program and the Electric Power Research Institute

On June 8-9, 2010, the staff participated in a Category 2 public meeting with the industry's Materials Reliability Program and the Electric Power Research Institute as part of the staff's review of Topical Report MRP-227, "Materials Reliability Program: Pressurized Water Reactor Internals Inspection and Evaluation Guidelines." MRP-227 represents the industry's proposed guidelines for an aging management program for pressurized water reactor internals in support of plant license renewal. In particular, it will assist licensees who have already received renewed licenses with meeting their commitments to submit aging management programs in this area prior to entering the period of extended operation. The purpose of the meeting was to discuss with the industry staff questions and concerns regarding the technical basis supporting MRP-227 and the scope of inspections proposed in MRP-227. Staff was provided with much needed background information that was either missing from, or unclear in, other technical reports which documented the technical basis for MRP-227. The staff is proceeding with its review and expects to issue a detailed set of follow-up questions in a request for additional information by mid-July 2010.

Office of Nuclear Material Safety and Safeguards (NMSS) Items of Interest Week Ending June 18, 2010

Meeting with Transnuclear, Inc.

On June 10, 2010, NRC staff, met with Transnuclear, Inc., (TN) to discuss the revised Fuel Drop Analysis performed by TN as part of a response to the second round request for additional information. The staff identified some specific aspects not considered by TN in its analysis. They include modeling appropriate gaps between fuel assemblies and internal packaging cavity, variability in the wood properties for impact limiters, and a high yield-strength value used by TN for the fuel cladding. TN agreed to address these issues in their analysis. TN needs also to submit their revised criticality analysis and address some clarifying questions in the shielding thermal areas before the staff can issue the Certificate of Compliance No. 9313 for the Model No. TN-40 transportation package.

Office of Nuclear Regulatory Research (RES) Items of Interest Week Ending June 18, 2010

<u>Publication of Draft Regulatory Guide 1240 (DG-1240) "Condition Monitoring Program for Electric Cables Used in Nuclear Power Plants"</u>

On June 15, 2010, RES staff issued DG-1240 to provide an opportunity for public comments. The draft guide is a proposed new guide that provides specific guidance for condition monitoring of cables to provide reasonable assurance that the cables are capable of performing their intended function(s) during their installed life. In particular, this regulatory guide describes a programmatic approach to condition monitoring of electric cable systems and their operating environments and acceptable condition-monitoring techniques. The Regulatory Process Training Course

On June 7, 2010, as a result of a competitive acquisition under the General Services Administration Federal Supply Schedule, a labor hour delivery order (NRC-38-10-710) was awarded to The Regulatory Group in Arlington, Virginia. The objective of this procurement is to provide the instructional and facilitation services for a course titled, "The Regulatory Process Course." The period of performance is June 7, 2010, through June 6, 2011, with four 1-year option periods. The total ceiling price is \$356,940.00, inclusive of all options.

<u>Technical Support in the Design of an Alternate Site to Support Disaster Recovery of Critical Information Technology (IT) Applications and Systems</u>

On June 9, 2010, as a result of a noncompetitive acquisition under the 8(a) program of the Small Business Administration, a firm fixed price contract (NRC-DR-33-10-317) was awarded to InfoAge Solution, Inc. in Washington, DC. The objective of this procurement is to provide technical support in the design of an alternate site to support disaster recovery of critical IT applications and systems. The period of performance is June 9, 2010, through August 27, 2010, with a total value of \$202,500.00.

<u>Technical Assistance for the Development of Environmental Documents for Uranium Recovery.</u>
Fuel Cycle Facilities, Decommissioning Licensing, and Other NRC Licensing Support Activities

On June 14, 2010, as a result of a noncompetitive acquisition, a cost plus fixed-fee type contract (NRC-41-10-015) was awarded to Straughan Environmental Services, Inc. in Columbia, Maryland. The objective of this procurement is to provide technical assistance to the Office of Federal and State Materials and Environmental Management Programs for supporting NRC staff in conducting environmental reviews for fuel cycle facilities, uranium recovery facilities, materials licensees, and decommissioning sites. The period of performance is June 14, 2010, through June 13, 2011, with two 1-year option periods. The total value is \$2,569,723.00, inclusive of all options.

<u>List of Approved Spent Fuel Storage Casks: MAGNASTOR System, Revision 1; Direct Final Rule (10 CFR PART 72) (Al86, NRC-2010-0140)</u>

On June 15, 2010, the NRC published a direct final rule (75 FR 33678) in the *Federal Register* that amends spent fuel storage regulations by revising the NAC International, Inc., MAGNASTOR System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 1 to Certificate of Compliance (CoC) Number 1031. Amendment No. 1 to the MAGNASTOR System CoC will change Technical Specifications (TS) related to neutron absorber qualification and acceptance testing. Specifically, the amendment will revise TS 4.1.1.b and incorporate by reference into the MAGNASTOR CoC, Sections 10.1.6.4.5, 10.1.6.4.6, 10.1.6.4.7, and 10.1.6.4.8 of the Final Safety Analysis Report regarding the acceptance testing of borated aluminum alloy and borated metal matrix composite neutron absorber material. The amendment will also include other changes in Appendices A and B of

the TS to incorporate minor editorial corrections. The direct final rule becomes effective August 30, 2010, unless significant adverse comments are received by July 15, 2010.

On June 15, 2010, the NRC published the companion proposed rule (75 FR 33736) to this direct final rule in the *Federal Register*. The comment period closes July 15, 2010.

Physical Protection of Byproduct Material; Proposed Rule (10 CFR PARTS 30, 32, 33, 34, 35, 36, 37, 39, 51, 71, and 73) (Al12, NRC-2008-0120)

On June 15, 2010, the NRC published a proposed rule (75 FR 33901) in the *Federal Register* that would amend its regulations to establish security requirements for the use and transport of category 1 and category 2 quantities of radioactive material which the NRC considers to be risk-significant; and therefore, warrants additional protection. Category 1 and category 2 thresholds are based on those established in the International Atomic Energy Agency Code of Conduct on the Safety and Security of Radioactive Sources, which NRC endorses. The objective of this proposed rule is to provide reasonable assurance of preventing the theft or diversion of category 1 and category 2 quantities of radioactive material. The proposed regulations would also include security requirements for the transportation of irradiated reactor fuel that weighs 100 grams or less in net weight of irradiated fuel. The proposed rule would affect any licensee that is authorized to possess category 1 or category 2 quantities of radioactive material, any licensee that transports these materials using ground transportation, and any licensee that transports small quantities of irradiated reactor fuel. Comments on the proposed rule are due October 13, 2010. Comments specific to the information collection aspects of the proposed rule are due by July 15, 2010.

General Electric Simulator Upgrade

On June 16, 2010, as a result of a full and open competition, a firm fixed price contract (NRC-38-10-702) was awarded to GSE Systems, Inc. in Columbia, Maryland. The objective of this procurement is to rehost the General Electric Simulator and provide digital control room capabilities. The period of performance is June 16, 2010, through June 15, 2011, with four 1-year option periods. The total contract value is \$1,248,067.00, inclusive of all options.

Freedom of Information Act Best Practices Working Group

On June 15, 2010, OIS staff attended a Freedom of Information Act - Best Practices Working Group sponsored by the Department of Justice, Office of Information Policy. The sharing of ideas between agencies will help ensure that the best ideas are not only known and shared between agencies, but also improved upon. This forum provided an opportunity for agencies to share successful strategies for facilitating access to records and increasing proactive disclosures. The topics of discussion included: applying the presumption of openness; creating an effective system for responding to requests; increasing proactive disclosure; utilizing technology; reducing backlogs; and improving timeliness.

National Archives and Records Administration Meeting

On June 15, 2010, OIS staff attended the Federal Records Center (FRC) Program Forum and the Bimonthly Records and Information Discussion Group (BRIDG) meeting, which were both hosted by the National Archives and Records Administration (NARA) in Washington, DC. The on-going deployment of NARA's Archives and Records Centers Information System was discussed at the FRC Forum. At the BRIDG meeting, NARA led discussions on Electronic Records Scheduling Workshops, NARA's Flexible Schedules Bulletin (2008-04), Electronic Records Summary Report, and the status of the FY 2010 Records Management Self-Assessment, a mandatory annual self-assessment conducted by every agency.
