St. Lucie 1 Extended Power Uprate (EPU) Application

By application dated November 22, 2010, the licensee re-submitted a request for an 11.9% EPU for St. Lucie Unit 1. The EPU application includes a 1.7% measurement uncertainty recapture power uprate. On August 13, 2010, the licensee withdrew its April 16, 2010, request for the EPU after the staff informed the licensee that the application lacked sufficient information to proceed with its detailed technical review. The November 22, 2010, application indicates that it addresses the information lacking in the earlier application and requests NRC approval by February 1, 2012, to allow implementation of the EPU during mid-cycle, after the fall 2011 refueling outage. The staff expects to be able to meet this schedule since NRC's standard review time for an EPU is 12 months after NRC's acceptance of the application.

Issuance of the Renewed Operating License for Cooper Nuclear Station

On November 29, 2010, the operating license for Cooper Nuclear Station was renewed authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration date is January 18, 2034. The staff completed the review as documented in the Safety Evaluation Report, NUREG-1944, published in October 2010 and Supplement 41 to the Generic Environmental Impact Statement for License Renewal of Nuclear Plants, NUREG-1437, published in July 2010. The issuance of the Cooper Nuclear Station renewed license brings the total number of renewals to 60 reactor units.

Meeting with the International Atomic Energy Agency (IAEA)

From December 1 to December 4, 2010, the staff attended an IAEA meeting in Vienna, Austria. The purpose of the meeting was to support the development of a Safety Guide for Electrical Systems at new nuclear plants. The Safety Guide will be used for design and construction of nuclear plants by developing nations and by IAEA inspectors to evaluate compliance of proposed plants with internationally accepted designs. NRC participants are providing input from USA design and regulatory perspectives.

Issuance of the Indian Point Nuclear Generating Unit Nos. 2 and 3 Generic Environmental Impact Statement, Supplement 38, Final Report

On December 3, 2010, the staff issued Supplement 38 to NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants Regarding Indian Point Nuclear Generating Units Nos. 2 and 3, Final Report." This supplemental environmental impact statement (SEIS) includes the staff's analysis that considers and weighs the environmental impacts of the proposed action, the environmental impacts of alternatives to the proposed action, and mitigation measures available for reducing or avoiding adverse impacts. It also includes the staff's recommendation regarding the proposed action: the adverse environmental impacts of license renewal are not so great that preserving the option of license renewal for energy planning decision-makers would be unreasonable. The staff will issue a *Federal Register* notice on the availability of the final SEIS.

Proposed Generic Communications Reporting for Decommissioning Funding Status Reports;
Notice of Opportunity for Public Comment (NRC-2010-0366)

On November 26, 2010, the NRC published a notice of opportunity (75 FR 72737) in the *Federal Register* for public comment on its proposal to issue a regulatory issue summary (RIS). The purpose of the RIS is to clarify information that licensees and external stakeholders should use and present to the NRC in their Decommissioning Funding Status reports. Further clarification will ensure that the NRC staff, licensees, and stakeholders are using consistent figures, and to prevent potential issues resulting from shortfalls in the licensee's decommissioning fund. The public comment period expires on December 27, 2010.

Final Rule: Miscellaneous Administrative Changes (NRC-2009-0085, RIN 3150-AH49)

On November 30, 2010, NRC published a final rule (75 FR 73935) in the *Federal Register* amending its regulations to make miscellaneous administrative changes. The changes include an update of the list of Agreement and Non-Agreement States, the merging of the Region II materials program with that of Region I, the correction of office titles associated with the Office of Nuclear Material Safety and Safeguards and the Office of Federal and State Materials and Environmental Management Programs, the inclusion of references to new Executive Order 13526, and other edits, corrections, and conforming changes. This rule is effective December 30, 2010.

Administrative Support and Clerical Occupations

On December 2, 2010, as a result of a competitive acquisition under the General Services Administrative Federal Supply Schedule, a labor-hour delivery order (NRC-HQ-11-F-31-P002) was awarded to Contract Consultants, Inc. of Bedford, Texas for administrative support services (a travel clerk and a mailroom clerk) for Region IV. The period of performance for this delivery order is January 1, 2011, through December 31, 2011, with four 1-year option years. The total price is \$546,100, which is inclusive of all options.
