Issuance of the Palo Verde Nuclear Generating Station License Renewal Generic Environmental Impact Statement, Supplement 43, Final Report

On January 3, 2011, the staff issued Supplement 43 to NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants Regarding Palo Verde Nuclear Generating Station, Final Report." This supplemental environmental impact statement (SEIS) includes the staff's analysis that considers and weighs the environmental effects of the proposed action, the environmental impacts of alternatives to the proposed action, and mitigation measures available for reducing or avoiding adverse impacts. It also includes the staff's recommendation regarding the proposed action: that the adverse environmental impacts of license renewal for Palo Verde Nuclear Generating Station are not great enough to deny the option of license renewal for energy-planning decision-makers. The final SEIS is publicly available in ADAMS using Accession No. ML103560149. The staff will issue a *Federal Register* notice on the availability of the final SEIS.

Publication of Revision 2 of Regulatory Guide (RG) 3.71, "Nuclear Criticality Safety Standards for Fuels and Material Facilities"

On January 3, 2011, the RES staff published revision 2 of RG 3.71, "Nuclear Criticality Safety Standards for Fuels and Material Facilities." This guide endorses—with some exceptions—specific nuclear criticality safety standards developed by the American Nuclear Society's Standards Subcommittee 8 (ANS-8), "Operations with Fissionable Materials Outside Reactors." RG 3.71 was developed to provide guidance, criteria, and best practices for use in preventing and mitigating criticality accidents during operations that involve handling, processing, storing, and/or transporting special nuclear material at fuel and material facilities. The guide is not intended for use by nuclear reactor licensees. RG 3.71 is available on the NRC Web site at: <http://www.nrc.gov/reading-rm/doc-collections/reg-guides/fuels-materials/rg/>.
