CONDITIONS

- 10. Individual glow switches distributed pursuant to this license shall contain not more than 0.5 microcuries of promethium-147, or 25 nanocuries of krypton-85, or 120 nanocuries of hydrogen-3, and individual arc tubes shall contain no more than 1 microcurie of krypton-85.
