Staff Issues Crystal River Unit 3 License Renewal Draft Supplemental Environmental Impact Statement (SEIS) for Public Comment

On May 26, 2011, the staff issued for public comment the draft of NUREG-1437, Generic Environmental Impact Statement for License Renewal of Nuclear Plants, Supplement 44, regarding Crystal River Unit 3 Nuclear Generating Plant. This SEIS includes the staff's preliminary analysis that considers and weighs the environmental effects of the proposed action, the environmental impacts of alternatives to the proposed action, and mitigative measures available for reducing or avoiding adverse impacts. It also includes the staff's preliminary recommendation that the adverse environmental impacts of license renewal for Crystal River Unit 3 are not great enough to deny the option of license renewal energy-planning decision-makers. The public comment period ends on July 25, 2011. The staff has scheduled public meetings near the plant on June 28, 2011, to present its analyses and accept public comments on the draft SEIS.

Pre-licensing Meeting with Union Electric Company

On May 26, 2011, representatives of the Union Electric Company and staff met at NRC Headquarters in Rockville, Maryland, to discuss the licensee's planned submittal of an amendment for Callaway Plant Unit 1, to revise the fire protection plan requirements to adopt the risk-informed, performance-based alternative described in "National Fire Protection Association (NFPA) Standard 805," as permitted by paragraph 50.48(c) of Title 10 of the *Code of Federal Regulations*.

Pre-licensing Meeting with Omaha Public Power District

On May 26, 2011, representatives of the Omaha Public Power District and staff held a publicly noticed conference call to discuss the licensee's planned submittal of an amendment for Fort Calhoun Station Unit 1, to revise the fire protection plan requirements to adopt the risk-informed, performance-based alternative described in "NFPA 805," as permitted by paragraph 50.48(c) of Title 10 of the *Code of Federal Regulations*.

Fire Protection Meeting on NFPA 805 Frequently Asked Questions (FAQs)

On May 26, 2011, the staff held a Category 2 public meeting with the Nuclear Energy Institute NFPA 805 Standard Task Force, other stakeholders, and the public to discuss the FAQs related to licensees' adoption of NFPA 805. The staff began holding these monthly public meetings in July 2006.

Workshop on Risk-Informed Regulatory Guidance

On May 26, 2011, the staff conducted the second of several tabletop exercises in response to the Staff Requirements Memorandum on SECY-10-0121 (risk-informed regulatory guidance for new reactors). During this workshop, participants discussed the experience of implementing risk-managed technical specifications at South Texas Project Units 1 and 2, as well as overall industry experience with the application of Maintenance Rule 50.65(a)(4). The staff presented results from scoping analyses using two new reactor Standardized Plant Analysis Risk models. Also, the discussion highlighted regulatory and programmatic controls that could limit a potential decrease in enhanced safety margins. During a follow-up workshop on June 1, 2011, industry representatives will present results of additional scoping analyses.

Medical Use Regulations; Availability of Preliminary Draft Rule Language and Notice of Public Workshops, 10 CFR Part 35 (RIN 3150-AI28, NRC-2008-0071 and RIN 3150-AI63, NRC-2008-0175)

On May 20, 2011, the NRC published for public comment (76 FR 29171) in the *Federal Register* preliminary draft rule language concerning the NRC's proposed amendments to the medical use regulations. The NRC plans to hold a public workshop on June 20-21, 2011, in New York, New York, to solicit comments on certain issues under consideration to amend the medical use regulations, including reporting and notifications of medical events for permanent implant brachytherapy. The NRC plans to hold a second public workshop on the same subject matter in August 2011 in Houston, Texas.

Public Meeting to Discuss the Proposed Rule on Enhanced Weapons, Firearms Background Checks, and Security Event Notifications, 10 CFR Part 73 (RIN 3150-AI49, NRC-2011-001, NRC-2011-0015, NRC-2011-0017, NRC-2011-0018)

Commissioner Ostendorff's nomination hearing before the Senate Environment and Public Works Committee.

A Nuclear and Radiation Studies Board Meeting where Commissioner Apostolakis presented the agency's response to events at Fukushima and ongoing efforts to examine the lessons learned from the situation.
