Issuance of the Safety Evaluation Report (SER) Related to the License Renewal of Diablo Canyon Nuclear Power Plant, Units 1 and 2

On June 2, 2011, the staff issued the SER related to the Diablo Canyon Nuclear Power Plant, Units 1 and 2, license renewal application. By letter dated November 23, 2009, Pacific Gas and Electric Company (PG&E) submitted the license renewal application to the staff, requesting the extension of the operating licenses for an additional 20 years beyond the current 40-year term. The staff performed its review in accordance with Title 10 of the *Code of Federal Regulations* Part 54, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants." By letter dated April 10, 2011, PG&E indicated that there will be a significant delay in receiving its coastal consistency certification, which is necessary for staff consideration prior to finalizing a decision on license renewal. As stated in the response letter dated May 31, 2011, the staff will supplement the SER, as necessary, considering any relevant new information, prior to a final agency decision. The date for the Advisory Committee on Reactor Safeguards meeting and any SER supplements will be determined at a later date and will be based on a timeline appropriately coordinated with PG&E's expected receipt of a coastal consistency certification.

Meeting to Discuss Sump Issues

On June 2, 2011, representatives of South Texas Project Nuclear Operating Company (STPNOC) met with the staff, to discuss Generic Safety Issue (GSI) 191, "Assessment of Debris Accumulation on PWR [Pressurized Water Reactor] Sump Performance." STPNOC discussed a risk-informed GSI-191 resolution option approach regarding South Texas Project, Units 1 and 2.

Inspection, Test, Analysis, and Acceptance Criteria (ITAAC) Workshop Public Meeting

On June 2, 2011, staff held a Category 3 public meeting as part of the ITAAC workshop series to discuss topics on the Construction Inspection Program. The meeting opened with a discussion regarding licensee commitments to utilize the ITAAC closure guidance in Nuclear Energy Institute (NEI) 08-01, and NRC Regulatory Guide (RG) 1.215. Licensees are planning to use the guidance and commit to the Regulatory Guide. As a result of the discussions, general agreement was reached that applicants would inform the NRC via a letter, indicating that they will revise their Final Standard Safety Analysis Report (FSAR) to include RG 1.215, as part of the first available FSAR update. The staff also presented status updates on the activities of the NRO Changes During Construction Working Group and the Construction Reactor Oversight Process, as well as the Expanded ITAAC Closure Notification Examples Project that proposes a new set of ITAAC closure letters be developed for the next revision of industry guide NEI 08-01. Westinghouse led a presentation on its understanding of environmental and seismic qualification audit activities included in the Standard Review Plan, and questioned how its interpretation could be duplicative of ITAAC inspection efforts. Staff explained the differences and added that there is no overlap. Industry also discussed its intentions regarding completion of "report ITAAC" closure submittals. Final discussions involved industry's request for staff to review 225-day notifications required by 10 CFR 52.99, and how more examples of these 225-day notifications might be included in the next NEI 08-01 revision.

The NRC's response to Pacific Gas and Electric Company's request to delay final issuance of a decision on their license renewal application for Diablo Canyon nuclear power plant (California).

A House Appropriations Committee draft of a 2012 spending bill that includes funding for Yucca Mountain for the NRC.

Two unexpected shutdowns at Limerick on May 28, 2011 and June 3, 2011.

Hardened vents at the Fermi nuclear power plant (Michigan).

Other Public Affairs Items:

OPA supported NRC Chairman Gregory B. Jaczko's visit to Robinson nuclear power plant (South Carolina) and the media teleconference held afterwards.

OPA supported annual assessment meetings at the Browns Ferry (Alabama) and Indian Point (New York) nuclear power plants. OPA spoke to several reporters on the Browns Ferry "red" inspection finding and did recorded interviews on Indian Point with radio stations WABC-AM and WCBS-AM.

OPA supported a nuclear conference on emergency preparedness sponsored by Johns Hopkins and The Atlantic Council in Washington where NRC Deputy Executive Director for Operations Martin Virgilio gave a speech.

OPA did a recorded interview with radio station WITF-FM (a National Public Radio affiliate in Harrisburg, Pennsylvania) about an amendment allowing low-level radioactive waste from the Limerick nuclear power plant (Pennsylvania) to be stored at Peach Bottom nuclear power plant (Pennsylvania).
