Controlled Unclassified Information (CUI) Working Group Meeting

On August 24, 2011, staff attended a CUI Working Group meeting at the Office of the CUI Executive Agent (EA). This was the third of weekly meetings to take place until early October 2011, during which agencies will work to standardize for common use across the Federal government the numerous proposed CUI categories and sub-categories that the EA received from agencies in May 2011. At this meeting, the topic of discussion was the "Privacy" category and its proposed subcategories. The discussion centered around whether two categories, "Privacy" and "Personally Identifiable Information," were sufficient for all government information of this nature, or whether it was necessary to have multiple subcategories. The EA will use the discussions and subsequent email input from agencies to further standardize and refine the "Privacy" category and subcategories. The next meeting, on September 1, 2011, will address the "Business Information" category and subcategories, which will include proprietary information.

Council of Agency Paperwork Reduction Act Officers Monthly Meeting

On August 25, 2011, staff from the Information and Records Services Division, OIS, attended a meeting convened by the Council of Agency Paperwork Reduction Act Officers at the Treasury Department. Agenda item included a live demonstration of the Paperwork Reduction Act Comments website, [www.pracomment.gov](http://www.pracomment.gov), which allows the public to submit comments on agency information collection activities. The site was developed by Google apps, and representatives from Google were present to answer questions about the site. The Treasury Department currently uses this website.

Pre-licensing Meeting with South Texas Project (STP) Nuclear Operating Company

On August 22, 2011, representatives of the STP Nuclear Operating Company and staff met to discuss the licensee's proposed risk-informed approach for resolving Generic Safety Issue No. 191 (GSI-191), "Assessment of Debris Accumulation on Pressurized-Water Reactor (PWR) Sump Performance," regarding STP, Units 1 and 2. This is the fifth pre-licensing meeting where the licensee has discussed its proposed use of the criteria in Regulatory Guide 1.174, "An Approach for Using Probabilistic Risk Assessment in Risk-Informed Decisions on Plant-Specific Changes to the Licensing Basis," to resolve GSI-191 for STP.

Staff Issues Columbia Generating Station License Renewal Draft Supplemental Environmental Impact Statement (SEIS) For Public Comment

On August 23, 2011, the staff issued for public comment the draft of NUREG-1437, Generic Environmental Impact Statement for License Renewal of Nuclear Plants, Supplement 47, Regarding Columbia Generating Station. This SEIS includes the staff's preliminary analysis that considers and weighs the environmental effects of the proposed action, the environmental impacts of alternatives to the proposed action, and mitigative measures available for reducing or avoiding adverse impacts. It also includes the staff's preliminary recommendation that the adverse environmental impacts of license renewal for Columbia Generating Station are not great enough to deny the option of license renewal for energy-planning decision-makers. The public comment period ends on November 16, 2011. The staff has scheduled public meetings near the plant on September 27, 2011, to present its analyses and accept public comments on the draft SEIS.

Fire Protection Meeting on National Fire Protection Association (NFPA) 805 Frequently Asked Questions

On August 25, 2011, the staff held, via teleconferencing, a Category 2 public meeting with the Nuclear Energy Institute NFPA Standard 805 Task Force, other stakeholders, and the public, to discuss the Frequently Asked Questions (FAQs) related to licensees' adoption of NFPA 805. The staff began holding these monthly public meetings in July 2006.

Non-Destructive Evaluation (NDE) Technical Advisory Group (TAG) Meeting

On August 23-25, 2011, RES hosted the bi-annual NDE TAG Meeting at the Pacific Northwest National Laboratory (PNNL). Over 30 staff members from NRR, RES, Regions I-IV, and PNNL discussed NDE-specific regulatory issues, emergent operational experience, regional topics, and regulatory research results relevant to regional inspectors and NRR. This meeting also provided an excellent opportunity for several new inspectors to gain experience from senior inspectors and staff. In addition to the meetings, PNNL provided tours of all of their NDE facilities as well as the Department of Energy Environmental Molecular Science Laboratory.
