Dispatch of Cooperating Agency Report for Fiscal Year (FY) 2011

On December 22, 2011, FSME's Division of Intergovernmental Liaison and Rulemaking signed and dispatched the NRC's Cooperating Agency Report for FY 2011. The report, an annual reporting requirement, lists all NRC Environmental Impact Statements (EISs) begun during Fiscal Year 2011 by a published Notice of Intent and Environmental Assessments completed during Fiscal Year 2011. The report cites formal involvement by the U.S. Army Corps of Engineers in two EISs for Early Site Permit applications -- Exelon's Victoria County Station located near McFaddin, Victoria County, Texas, and Public Service Enterprise Group's new power reactor project located in Lower Alloways Creek Township, Salem County, New Jersey.

Approval of the AP1000 Amendment Design Certification Final Rule and Publication in the
Federal Register

On December 22, 2011, the Commission approved a final rule amending Title 10 of the *Code of Federal Regulations* (10 CFR), Part 52, Appendix D, "Design Certification Rule for the AP1000 Design". This amendment replaces certain combined license information items and design acceptance criteria with specific design information, addresses the effects of the impact of a large commercial aircraft, incorporates design improvements, and increases standardization of the design. On December 30, 2011, the final rule amending Appendix D to 10 CFR Part 52, "Design Certification Rule for the AP1000 Design," was published in the *Federal Register*.

Watts Bar 2 – Fire Protection Safety Review

On December 21, the NRC staff met with the Tennessee Valley Authority (TVA) staff in a public meeting to discuss the November 30, 2011, fire protection submittal to support the safety review of the Watts Bar 2 application. During the meeting, NRC and TVA staff discussed corrections and enhancements that needed to be made to the submittal. NRR project management staff is working with TVA staff to determine the timetable to resubmit the corrected fire protection information.
