 The purpose of this modification is to extend the period of performance from December 20, 2011 to June 30, 2012 at no additional cost to the Government. The Boiling Water Reactor Owners' Group (BWROG) had requested that their staff experts address the proposed guidance on the use of containment accident pressure in determining available NPSH. Upon receipt of this additional information Mr. Burdris support will be required to evaluate the BWROG information. Accordingly the contract is modified as follows:
 The period of performance is revised in its entirety and replaced with the following:
 "The period of performance is from December 20, 2011 through June 30, 2012."
