This letter is in reference to CIN 575605 and provides information regarding ownership and name change for the prior licensed LakeView Community Hospital.

On January 1, 2008, LakeView Community Hospital was fully acquired by the Bronson Healthcare Group, Kalamazoo, Michigan, and its name was changed to Bronson LakeView Hospital (Question 1). No changes in personnel or duties changed during the ownership transition or since (Question 2). There have not been any changes in the organization, location, facilities, equipment or procedures since the ownership changes (Question 3). All surveillance, safety, recordkeeping, etc. (Questions 4 and 5) are maintained by contract with Radiological Physics Services, Inc. I have attached the contact information.

In closing, a change of name and ownership occurred on January 1, 2008, but all aspects of the service, including the commitment to abide by all constraints, conditions and requirements has not changed (Question 6).
