Thank you for your continued review of this amendment. I contacted Mr. Ed Wroblewski, DABSNM, the Diagnostic Medical Physicist who completed the shielding calculations for the PET/CT Project at Franciscan St. Francis Health. He stated the exposure values to adjacent areas were calculated to assure the dose in any unrestricted area from external sources, exclusive of the dose contributions from patients administered radioactive material and released in accordance with § 35.75, does not exceed 0.002 rem (0.02 millisievert) in any one hour. Occupationally exposed radiation workers will be issued radiation dosimetry devices to assure compliance with 20.1201 "Occupational dose limits for adults".

Furthermore, it is anticipated that upon completion of the project and subsequent administration and imaging of individuals who have been administered PET radiopharmaceuticals a radiation safety survey shall be performed in areas adjacent to the areas described within the amendment request of Dec. 01, 2011, to assure the 0.002 rem in any one hour criteria is met.
